Schedule 2: New Works Requirements**Part 6: Relevant Authorities and Interested Parties****1. General**

- 1.1 Without prejudice to any part of this Agreement, the Company shall comply with the requirements of the Relevant Authorities insofar as they relate to the New Works, provided always that the Company's compliance with the said requirements shall not prevent the Company from negotiating the terms and conditions of such requirements with the appropriate Relevant Authority.
- 1.2 Where within the Agreement there is a requirement, or where it is otherwise necessary, to consult and/or liaise with a Relevant Authority, the Company shall identify the Relevant Authority and comply with all their requirements whether or not all such requirements of the Relevant Authority are identified within the Agreement.
- 1.3 Where as a consequence of consultation or liaison with a Relevant Authority a requirement is specified which contradicts any other requirement of this Agreement, the Company shall refer the matter to Angus Council who shall determine which requirement shall prevail.
- 1.4 Without prejudice to any part of this Agreement, the Company shall consult with those Interested Parties detailed in this Part as appropriate, and shall where reasonable take account of comments received.
- 1.5 Where within the Agreement there is a requirement, or where it is otherwise necessary, to consult and/or liaise with an Interested Party the Company shall identify the Interested Party and consult with them whether or not the Interested Party is identified within this Agreement. The Company shall where reasonable take account of comments received by consultation.
- 1.6 Reference to those Relevant Authorities or Interested Parties within this Part shall mean these Relevant Authorities or Interested Parties or their successor(s).
- 1.7 The Company shall take all necessary measures to avoid causing damage to services. The Company shall make its own detailed inquiries of the Relevant Authorities and shall satisfy itself as to the existence of the exact position of such apparatus and the depth, size and gradient thereof.
