DECLARATIONS:-

1. I am aware of the provisions of the Riding Establishments Acts 1964 and 1970 and I apply for a licence to keep a riding establishment.
2. I enclose the appropriate lodging fee and the policy or other evidence of insurance referred to at question 12(ii).
3. I hereby instruct Angus Council to arrange an inspection of the above riding establishment and agree to meet any costs incurred by the Council.
4. Angus Council is under a duty to protect the public funds it administers. As a result, the information you have provided or the information provided about you by a third party will be passed to the Council's Finance Division to check whether you have outstanding debts with the Council in relation to such matters as Council tax and non-domestic rates. The Council may also share information about you with other Departments of the Council and with other bodies administering public funds for the prevention of crime and the detection of fraud, such as Government departments and other local authorities.

NOTES:-

1. A licence may be granted to an applicant over the age of 18 years.

It will be a condition of any licence granted that the carrying on of the business of a riding establishment shall at no time be left in the charge of any person under 16 years of age.

2. It will be a condition of any licence granted that no horse will be let out on hire for riding or used for providing instruction in riding without supervision by a responsible person of the age of 16 years or over unless (in the case of a horse let out for hire for riding) the holder of the licence is satisfied that the hirer of the horse is competent to ride without supervision.
3. (i) "Horse" includes any mare, gelding, pony, foal, colt, filly or stallion and also any ass, mule or jennet.

(ii) The Acts regulate riding establishments which let out horses or hire or use them for the purpose of providing, in return for payment, instruction in riding or for the purpose of demonstrating riding.
4. A licence is valid for one year from the date of grant.
5. To be lodged with the Head of Law and Administration, Angus Council, Forfar together with the appropriate lodging fee. The application will not be processed without payment of the appropriate fee.
6. Any person who in, or in connection with, the making of this application makes any statement which he knows to be false or recklessly makes any statement which is false in a material particular shall be guilty of an offence and liable, on summary conviction, to a fine not exceeding £2,500.
