Your Questions Answered

1. How old should my child be?

All children in their pre-school year (3½ - 4½ years old) are eligible for a place anytime throughout the school year.

Children in their ante-pre-school year (3 years old) are eligible for a place at specific times throughout the school year. The dates below indicate when your child becomes eligible for a funded place:

2. To which Pre-School Provision should I apply?

Choose the pre-school provision which best meets your child's and family's needs. This could either be within a local authority pre-school class or with a Private and Voluntary Provider who is in partnership with Angus Council. You may, of course, wish your child to attend the pre-school class in the school which serves the area in which you reside. 3. When do I have to enrol?

You can enrol your child provisionally at anytime. However, for children eligible to start for the first time in August or who are moving to an alternative provider for the start of a school year, your application should be in your preferred provider's hands by the end of February. Any applications received after the end of February will be treated as a "late application" and will not be considered until the next intake date in September (discretion will be used where a child moves into the area).

4. How do I enrol my child?

You can collect an application form from the provider of your choice. This provisional registration form should be returned in good time. Please ensure that you take your child's birth certificate and two proofs of residence (e.g. council tax/utility bill) along with you, otherwise your application form will not be processed.

The categories below are only used as a means of prioritising the initial allocation of places. Once a child has been given a place, these categories are not used in determining the allocation of am/pm places.

For your information the three categories used for the initial allocation of Angus Council Education Department pre-school places are:

Category 1 Children in their pre-school year (4 year olds) living within the delineated area of the pre-school class

Category 2 Children in their ante-pre-school year (3 year olds) living within the delineated area of the pre-school class

Category 3 Children living outwith the delineated area of the pre-school class

Private and voluntary providers have their own admission policies. You will be provided with the details of your chosen provider's policy on request.

5. My child has additional support needs.

What provision could be made for him/her?

Many children with additional support needs attend their local pre-school class. There are also pre-school classes in Arbroath, Brechin,

Carnoustie, Forfar, Kirriemuir, Montrose, and Monifieth for children who have more significant educational needs. Further information can be obtained by telephoning the ACCESSLine on 08452 777 778. You will then be put in touch with a member of the Education Department staff who will be pleased to discuss your child's needs with you.

6. Can I apply to more than one pre-school class?

No. You should only submit an application form to your first choice of pre-school. Double applications would be rejected automatically and parents/carers would only be approached after all other applications had been considered.

7. What happens if my child does not get into the pre-school centre of my choice?

Every effort will be made to offer you the place of your choice. If, however, the centre is over-subscribed the categorisation system outlined in answer 4 will be applied where refusals have to be made. If your pre-school centre is over subscribed, you should contact the ACCESSLine on 08452 777 778. You will then be put in touch with a member of staff from the Education Department who will discuss possible alternatives with you.

8. Will my child receive a morning or an afternoon session?

Whenever possible, parental preferences, where indicated, are met. However, school operational needs may be such that requests exceed the number of places available in either the morning or afternoon session. In these cases, the single criterion of age (with priority being given to the oldest) will be used. This approach ensures that as many preferences as possible are met over the period of your child's attendance at pre-school.

NB Children who are already in attendance at a pre-school, regardless of age, may retain their current am/pm place unless the school is advised by the parent that they wish this to change.

9. What does pre-school provision mean for my child?

Your child is entitled to 12.5 hours of pre-school education each week. Each session will last two and a half hours.

10. Does my child have to attend each day?

There are considerable educational benefits to be gained from regular daily attendance. Children attending a primary school pre-school class are usually required to attend 5 sessions per week (either 5 mornings or 5 afternoons). However, more flexible arrangements can be negotiated with private and voluntary providers.

11. Are there any charges for the provision?

There are no charges for the five sessions of pre-school education provided each week for eligible children. To cover snack provision, a small charge is levied each week. Private nurseries will also charge for extended periods of care outwith the 2½ hours of funded pre-school education. Full details of these charges can be obtained from individual providers.

12. When will my child move on to school?

Children normally start primary school when they are aged between 4½ and 5½. Parents of children who are not yet five at the start of the school session have the right to delay their child's entry to primary school for a further year. Parents, who feel that they would like to explore this course of action, should speak to the staff in their pre-school centre before the end of February in any given year. Staff will also provide you with more detailed information about funding criteria.

13. Which Primary School does my child have to attend?

It is usual for children to attend their local delineated area school. However, parents have the right to request another school by making a placing request. This placing request will be granted, wherever possible, provided there are available places at the chosen school and there are no legal grounds for refusing the request.
