SIX MONTH PERFORMANCE REPORT – ANGUS SINGLE OUTCOME AGREEMENT 2009/2012

**ABSTRACT:**

This report presents a six month performance report on the Angus Single Outcome Agreement 2009/2012 covering the period July - December 2009.

**2. BACKGROUND**

The Single Outcome Agreement 2009/2012 is a partnership agreement between the council, our community planning partners and Scottish Government.

It describes the partnership's key local priorities and outcomes for individuals and communities and how these will be measured.

At the meeting of this committee on 3 February 2009 it was agreed to monitor progress of the Single Outcome Agreement on a six month basis.

**3. SIX MONTH PERFORMANCE REPORT OF THE ANGUS SINGLE OUTCOME AGREEMENT 2009/2012**

The overall performance of the Angus Community Planning Partnership is very positive. Out of a possible 42 indicators, 33 have already met or exceeded the target set in the first half of the year, where comparable data is available.

The Angus Community Planning Partnership's Single Outcome Agreement Implementation Group ensures the management of performance on a regular basis throughout the year.

The Implementation Group are currently working with all thematic groups to develop delivery plans to ensure that outcomes for individuals and communities are being met.
