Councillor G Middleton was Deputy Convener of the Tayside Community Justice Authority for the above period and £3,045 of the remuneration figure and £192.40 of the expenses total shown has been paid by the Justice Authority rather than Angus Council.									
Councillor R Murray is a Vice-President of COSLA and as such all expenses incurred by him in undertaking COSLA duties are reclaimed from COSLA. Included in the above expenses total is £1,274.33 which has been reclaimed from COSLA.
