The above allowances and expenses were payable under the Local Governance (Scotland) Act 2004 (Remuneration) Regulations 2007 and the Local Government (Allowances and Expenses) (Scotland) Regulations 2007.								
Councillor I Mackintosh was Convener of the Tayside Joint Police Board for the above period and £7,921 of the remuneration figure shown has been paid by the Joint Board rather than Angus Council.								
Councillor G Middleton was Deputy Convener of the Tayside Community Justice Authority for the above period and £2,971 of the remuneration figure shown has been paid by the Justice Authority rather than Angus Council.								
Councillor R Murray is a Vice-President of COSLA and as such all expenses incurred by him in undertaking COSLA duties are reclaimed from COSLA. Included in the above expenses total is £2,291.86 which has been reclaimed from COSLA.								
Provost R Leslie-Melville is the Council's Civic Head and is entitled to reclaim receipted expenditure incurred in carrying out her civic duties up to a maximum of £3,000 p.a. The sum of £1,845 is included within the amount of £2,445 of other expenses which relates to these civic duties
