



# Angus Concession Scheme

Concessionary Access Discount System



**The Angus Concession Scheme is a concessionary access discount system, which entitles customers to a wide range of leisure and sports activities throughout Angus Leisure facilities.**

With the Angus Concession Scheme you can take advantage of the savings whatever your leisure interests may be.

The scheme also allows you to book 7 days in advance allowing you to reserve a place in your favourite class or a five-a-side court for your weekly game of football.

**So with such a wide range of benefits to choose from how can you afford not to?**

The Angus Concession Scheme is available to concessionary users and proof of concession entitlement must be shown. i.e. 17+ in full time education, disabled, unemployed, 60+, Residents in receipt of Working Family Tax Credit with entitlement to free prescriptions.

Memberships last for 12 months from date of sign up.

The following terms and conditions apply and you are asked to read them before submitting your application. A signed application form is your formal acceptance of these terms and conditions.

**Terms and conditions for making use of the Angus Concession Scheme by card holders**

For the purposes of this scheme the term: 'Individual' means any person.

1. Cards must be presented to obtain any agreed benefit that may be offered from time to time as part of a promotion authorised by Angus Council.
2. Cards may be used to book facilities up to 7 days in advance.
3. All customers entitled to concessionary rates are required to join the Angus Concession Scheme and proof of entitlement will be required on an annual basis
4. The cardholder must comply with the management rules of the council's leisure facilities.
5. Cards can be used at all Angus Council indoor leisure facilities.
6. Cards remain the property of Angus Council
7. Angus Council reserves the right to refuse or suspend the use of any card.
8. Lost or stolen cards should be reported as soon as possible to the reception desk at any Angus Council Indoor Leisure Facility. An administration fee will be charged for cards which need replaced.
