Payments

Initial payments will be accepted only by:

- Cheques (payable to Angus Council) or
- Cash

General Terms and Conditions

- Once the bACTIVE Membership agreement has been entered into you will be deemed to have accepted the terms and conditions of the scheme and as such will be bound by these until the agreement is terminated in accordance with these conditions.
- Your bACTIVE Membership method of payment will continue as long as you continue to pay the monthly fee by direct debit.
- All bACTIVE Memberships are legally binding contracts between the user and Angus Council and represent a commitment to pay all monthly payments until the contract is terminated.
- bACTIVE Membership Direct Debit fees are non-refundable.
- Up/downgrade or changes of any of the Membership Direct Debit options are available.
- Notification of any change of circumstance must be given in writing to Angus Council Leisure Services.
- To qualify for joint bACTIVE Membership - two people must be staying at the same address.
- A family membership option will be available for a maximum of two adults and any child aged 16 or under or still in secondary education staying at the same address.
- Concessionary membership is available when proof of concessionary entitlement is shown i.e. 17+ in full time education, people with a disability, unemployed, 60+, residents in receipt of Working Family Tax Credit with entitlement to free prescriptions.
- bACTIVE Memberships will allow the user to gain access relevant to the category of payment.
- Angus Council reserve the right to review monthly Direct Debit fees on an annual basis.
- bACTIVE Memberships are not transferable and any use other than by the named person will result in cancellation with no refund available. Cards remain the property of Angus Council.

- Angus Council reserves the right to refuse any holder of a Routes to Leisure user card access to the bACTIVE Membership scheme.

Cancellation of Direct Debit

- If Angus Council wish to cancel the bACTIVE Membership – a minimum of one months notice will be issued in writing by Angus Council.
- If you wish to cancel your bACTIVE Membership you must send written notice to Angus Council - Leisure Services, The Yard, Queenswell Road, Forfar DD8 3JA by giving a minimum of one months notice in writing and pay any fees that are due up to the date of cancellation.
- To re-instate your Direct Debit method of payment all arrears plus a start-up fee will be charged.
- Any member whose bACTIVE Membership is rejected on 2 consecutive occasions will have his/her Direct Debit method of payment terminated. For re-instatement see (c) above.

Replacement Cards

- Lost or stolen cards should be reported as soon as possible to the reception desk at any Angus Council Indoor Leisure Facility. An administration fee will be charged for cards which need replaced.

Management Rules

- Please note that all users are bound by Angus Council Management Rules. We reserve the right to refuse admission or ask you to leave any Angus Council Leisure Management Facility if we reasonably believe that you are in breach of any section of the Rules.
- bACTIVE Membership Cards must be used to gain entry every time a visit is made.
- bACTIVE Membership cards can only be used for Angus Council Indoor Leisure facilities during the stated opening hours. It does not guarantee the holder access to the facilities/ activities or booking of any of the facilities/ activities.
- bACTIVE Membership cards can only be used for Angus Council Indoor Leisure Management run classes. They are not eligible for private or pre paid classes, or club bookings.

bACTIVE is an unlimited membership scheme paid by direct debit It gives users the opportunity to enjoy their leisure activities for a set monthly fee.
