MINUTE of Special MEETING of **ANGUS COUNCIL** held in the Town and County Hall, Forfar on Thursday 4 August 2016 at 2.00pm.

### 3. ANGUS LOCAL DEVELOPMENT PLAN POST EXAMINATION MODIFICATION AND ADOPTION

With reference to Article 11 of the minute of meeting of Angus Council of 10 September 2015, there was submitted Report No 277/16 by the Head of Planning and Place presenting the conclusions and recommended modifications arising out of the examination of unresolved representations to the Proposed Angus Local Development Plan.

The Report recommended that the Council accepted all the recommended modifications as set out in the Examination Report along with the consequential changes, technical changes and that the Council agrees to adopt the plan and the procedures required to do so.

Having heard from Councillor Murray who commended the Report and congratulated Planning Service staff for the significant work undertaken, the Council unanimously agreed:-

- (i) to note the contents of the Examination Report on the Proposed Angus Local Development Plan (Appendix 1 of the Report);
- (ii) to approve the modifications recommended in the Examination Report along with the consequential and technical changes identified by officers (Appendices 2 and 3 of the Report);
- (iii) to authorise the Head of Planning and Place to notify the Scottish Ministers of the Council's intention to adopt the Proposed Angus Local Development Plan as Modified (Appendix 4 of the Report);
- (iv) to the adoption of the Proposed Angus Local Development Plan as Modified following completion of the relevant statutory pre-adoption procedures; and
- (v) to instruct the Head of Planning and Place to report to Angus Council the updated Action Programme and the Strategic Environmental Assessment Post Adoption Statement.
