### 6. RECRUITMENT OF INDEPENDENT PERSONS TO THE SOCIAL WORK COMPLAINTS REVIEW COMMITTEE

The Council has a statutory obligation to establish a Social Work Complaints Review Committee which is made up of three independent persons. Membership of the Committee is drawn from a Social Work Review Panel. Elected members or officers of a local authority are not eligible to be appointed to the Panel.

Currently the membership of the Panel is at the minimum of 3 and the Council is asked to delegate to the Head of Legal and Democratic Services authority to make appointments to the Review Committee to ensure there are sufficient numbers to hold a Review Hearing.
