(a) Previous Meeting

5. PRIMARY SCHOOL CAPACITIES

With reference to Article 9 of the minute of meeting of this Committee of 24 February 2015, there was submitted Report No 141/15 by the Strategic Director – People summarising new primary school capacities following a review of the current methodology in line with recently published Scottish Government guidance; seeking approval to cap the roll of Hayshead, Inverbrothock, Langlands, Mattocks, St Thomas, Timmergreens and Woodlands Primary Schools and to apply the principle of reserve places in these schools.
