MINUTE of MEETING of **ANGUS COUNCIL** held in the Town and County Hall, Forfar on Thursday 8 December 2016 at 2.00pm.

Councillor Boyd was duly appointed Convener of the Scrutiny and Audit Committee.

Vice Convener of Scrutiny and Audit Committee

As a consequence of the above, Provost Alex King called for nominations for Vice Convener of the Scrutiny and Audit Committee.

Depute Provost Boyd, seconded by Councillor Iain Gaul, moved that Councillor Fotheringham be appointed Vice Convener of the Scrutiny and Audit Committee.

The Council resolved to have a ten minute adjournment.

The meeting reconvened at 2.24pm.

Councillor Fotheringham intimated that, as all members of the Council were not present, he did not wish to be nominated for the position of Vice Convener of the Scrutiny and Audit Committee.

Thereafter, Depute Provost Boyd, seconded by Councillor Iain Gaul, moved that Councillor Cheape be appointed Vice Convener of the Scrutiny and Audit Committee.

There being no other nominations, Councillor Cheape was duly appointed Vice Convener of the Scrutiny and Audit Committee.

8. REVIEW OF POLLING DISTRICTS AND POLLING PLACES

With reference to Article 6 of the minute of meeting of Angus Council of 16 June 2016, there was submitted Report No 437/16 by the Chief Executive and Returning Officer advising members of the completion of the Local Government Boundary Commission for Scotland's Fifth Statutory Review of Electoral Arrangements following approval by Scottish Ministers and proposing amendments to the Council's polling scheme in light of this review and the closure of a polling venue in Brechin.

The Council resolved:-

- to note the amendments to Wards 5, 6 and 7 of Angus Council as a result of the Local Government Boundary Review, as per maps 1 to 3 contained in Appendix 1 to the Report;
- to note the amendment to the name of Ward 6 to Arbroath West, Letham and Friockheim and the reduction in councillor numbers from 4 to 3 in Ward 7 Arbroath East & Lunan;
- (iii) to note that the Scottish Local Government Elections due to be held on 4 May 2017 would be contested on the new ward boundaries and councillor numbers;
- to approve the amendments to the current parliamentary polling districts and polling places, as outlined in maps 1 to 3 contained in Appendix 1 of the Report as a result of the review;
- (v) to approve the amendments to the polling arrangements in Brechin, as outlined in map 4 in Appendix 1 to the Report; and
- (vi) to note that the Electoral Registration Officer (ERO) would arrange to make the necessary amendments to the 2016/17 Register of Electors.

9. TREASURY MANAGEMENT 2016/17 MID YEAR REVIEW REPORT

With reference to Article 13 of the minute of meeting of Angus Council of 10 December 2015, there was submitted Report No 438/16 by the Head of Corporate Improvement and Finance providing details of the mid term review on treasury management activities for the period 1 April to 30 September 2016.

The Report indicated that during the first six months of the financial year the Council had operated within the treasury limits and prudential indicators set out in the Council's 2016/17 Treasury Management Strategy Statement and in compliance with the Council's Treasury Management practices.

The Council resolved to note the Angus Council mid year review report on treasury management activities for the period 1 April to 30 September 2016, attached as Appendix 1 to the Report.

10. ANGUS LOCAL DEVELOPMENT PLAN – ACTION PROGRAMME AND STRATEGIC ENVIRONMENTAL ASSESSMENT POST ADOPTION STATEMENT

With reference to Article 3 of the minute of the special meeting of Angus Council of 4 August 2016, there was submitted Report No 439/16 by the Head of Planning and Place seeking approval of the Action Programme for the Angus Local Development Plan. The Report also

sought agreement of the Strategic Environmental Assessment Post Adoption Statement of the Angus Local Development Plan.

The Council resolved:-

- (i) to approve the Angus Local Development Plan Action Programme for adoption, submission and publication, attached as Appendix 1 to the Report; and
- (ii) to approve the Strategic Environmental Assessment Post Adoption Statement for the Angus Local Development Plan, subject to minor technical drafting amendments, attached as Appendix 2 to the Report.

11. ANGUS LOCAL DEVELOPMENT PLAN SUPPLEMENTARY GUIDANCE

With reference to Article 10 of the minute of meeting of Angus Council of 8 September 2016, there was submitted Report No 440/16 by the Head of Planning and Place providing an update on the response from Scottish Ministers to the notice of intention to adopt the Angus Local Development Plan Supplementary Guidance on Developer Contributions and Affordable Housing and recommending that the Supplementary Guidance be updated and adopted in line with the direction issued by Scottish Ministers.

The Council resolved to adopt the Developer Contributions and Affordable Housing Supplementary Guidance, in line with the direction issued by Scottish Ministers.

12. JOINT INSPECTION OF SERVICES FOR CHILDREN AND YOUNG PEOPLE IN THE ANGUS COMMUNITY PLANNING PARTNERSHIP (ACPP)

There was submitted Report No 441/16 by the Strategic Director – Children and Learning informing members of the outcomes of the joint inspection of services for children and young people in Angus.

The Report indicated that the inspection of all children's services in the Angus Community Planning Partnership had taken place between 16 May and 24 June 2016 and had involved Care Inspectorate, Education Scotland, Health Care Improvement Scotland and Her Majesty's Inspectorate of Constabulary for Scotland. The final inspection report had been published on the Care Inspectorate's website on 29 November 2016 and detailed a number of areas of particular strengths along with examples of good practice and areas identified for improvement. It was proposed that a further report be taken to the Children and Learning Committee with an action plan to address areas for improvement from the inspection.

The Council resolved:

- (i) to note the contents of the Report;
- (ii) to acknowledge the strengths of the multi agency partnership in Angus; and
- (iii) to request that the Strategic Director Children and Learning present a multi agency action plan to address the areas for improvement to the Children and Learning Committee in February 2017.
