I object to the application for the same reasons I objected to the previous two applications, both of which were withdrawn, and my objection still stands.

I cannot understand why the applicants would think that a single turbine, which will have much bigger blades, a 200kw power source will be better than two 100kw turbines, the visual impact remains and the noise, shadow flicker will be twice as bad, are we certain that there will be no disruption to communication signals, and health risks have still not been conclusively ruled out. Angus council have already passed one of these money making monstrosities at Broom Farm, which is less than 2km away from this proposed site, surely that falls within your own wind energy assessment which states there needs to be a 3km seperation distance.

Another 2 turbines have now gone up near Memus, which again is very close to the village, and since being erected have barely worked., it took at least 2 months for one of them to start working, so what was the great rush in getting them erected.

If the power generated is for personal consumption, why the need for such a huge turbine, the simple answer is greed, we all know the government subsidies are a huge profit making exercise for the individuals who want make as much profit as possible, at the expense of our wonderful, peaceful countryside and the people who have worked hard and are still working hard, to live in quiet unspoiled area.

There are other options available to produce the green energy the owners of Kalula house can implement if they choose to do so, that would have much less impact on the area and the community, but perhaps this would not be as profitable for them.

I live in Tannadice, which is a beautiful village with a strong community, it is also a conservation village, where a neighbour was not allowed to erect a 5ft fence because it was considered too high, and not in keeping with the surrounds, and a 44 mtr turbine is in keeping?.

Further to your recent communication re the above appeal I would like to raise the following further points in addition to my original objections which stand.

This appeal represents the the latest in a series of attempts to push this development through and the applicant (or the consultant or contractor involved) and appears to be determined not to take account of the legitimate objections of the local community which have been upheld in successive applications. Whilst we can appreciate the desire of the developer to exhaust every possibility to have the application approved clearly there is no justification for overturning the previous decision, particularly given there is no change to the application.

Since this application was submitted there have been three wind turbines erected locally all of which impact adversely on local amenity, landscape and views with no evident benefit to the local community. Indeed the turbine erected at Broom Farm demonstrates clearly just how visually and contextually inappropriate this proposed turbine and its scale would be in the proposed location, one of the few unspoiled local sightlines left. This location would dominate two of the approaches to Tannadice leaving only the route from Finavon with no direct proximity to wind turbines, turbines would thus become a defining features of the local landscape surrounding this conservation village. Clearly as their local impact would now compound that of these newly installed developments this application can no longer be considered in isolation. The cumulative impact of this development would be even more detrimental than at the time of the original decision to refuse the application.
