4. FINANCIAL IMPLICATIONS

4.1 Angus Council Community Grant Scheme - 2015/16

Following the end of year budget announcement the Angus Council Community Grant Scheme 2015/16 revenue budget is £51,000. As in 2014/15, Communities have also indicated a contribution of £7,000 bringing the total amount available to £58,000. This base provision has been augmented by the 100% carry forward amount from 2014/15 of £9,248.42 being the balance of resources available from the Grant Scheme giving a total sum available of £67,248.42.

- 4.2 From 1 April 2015 until 31 March 2016 or until the funding is fully subscribed there is a ringfenced amount of £15,000 available for Food and Drink projects in support of the Scottish Government Focus Years programme as outlined in report 110/15.
- 4.3 The amount submitted for approval in this Report for 2015/16 totals £16,658.40
- 4.4 An uncommitted balance of £40,590.02 is available to fund grant applications for the remainder of 2015/16 which includes the £15,000 for food and drink activity.
