ABSTRACT

				The group is also seeking funding for the fabrication of a water slide and dinghies. The water slide is intended to be an added attraction at events particularly for younger people and it is hoped that this will encourage them to become more involved in the events.
				The provision of the stalls will help other organisations/groups in the area promote their activities and the water slide is a novel and fun way of attracting young people to these events and engaging with them and can be re-used.

4. FINANCIAL IMPLICATIONS

4.1 Angus Council Community Grant Scheme - 2014/15

The base provision for the Angus Council Community Grant Scheme contained within the 2014/15 revenue budget totals £60,500 comprising Education - £9,500 (TBC); and Other Services revenue budget - £51,000. This base provision will be augmented by the 100% carry forward amount from 2013/14 of circa £59,000 being the balance of resources available from both the Grants Scheme and the Events Funds. The exact sum will be confirmed as part of the final accounts process and an update will be included in future reports on the Grant Scheme.

- 4.2 Overall a budget of around £119,500 is estimated to be available in 2014/15.
- 4.3 The amount submitted for approval in this Report for 2014/15 totals £11,716.00 (£1,775.00 and £9,941.00). The recommended amount of £11,716.00 combined with other grant approvals in 2014/15 of £36,869.48 brings the total commitment in 2014/15 to £48,585.48, which can be met from the 2014/15 budget provision.
- 4.4 In addition a sum of £50,000 has been set aside for the Commonwealth Games Fund (report 185/14 refers), leaving an uncommitted balance of around £19,000 will be available to fund further grants in 2014/15. However any unused funds for the Commonwealth Games fund will be then made available to fund Grant Scheme applications for the remainder of 2014/15.
