Commentary on Net Capital Expenditure Against Budget

A commentary on the significant areas of variance between budget and actual for each council directorate is outlined below:

Project plan (which detailed outstanding works that main contractor was required to make good by a certain date) not delivered in full prior to the agreed deadline therefore work orders issued to term contractors to complete. Replacement of Kinnaird Street Residential Home, Arbroath (Children & Young People's Services) – underspend as completion date slipped from April to June 2015. Arbroath Schools Project – Phase 1 (Schools & Learning) – project procured by the Scottish Futures Trust procurement vehicle Hubco and slippage has arisen as a result of contractor issues resulting in subsequent delays in the construction start date. Brechin High School Community Campus (Schools & Learning) – site slippage / delays, particularly weather conditions impacting on progress with the concrete / frame. It should be noted however that this is largely financial slippage rather than construction slippage. Forfar Academy Community Campus (Schools & Learning) – overspend relating to advance works undertaken during protracted financial close period in order to keep timescales on track (external funding will be received to offset these works).

Commentary Against Last Projected Outturn

The most recent projected outturn for 2014/15 based on February 2015 ledgers showed an anticipated underspend on a net basis for General Fund services of £6.074m (report 173/15 refers). The actual underspend of £8.999m at the year end shows an increase in the underspend of £2.925m from the previously reported position.

With regard to Housing, the February 2015 position showed a projected underspend on a net basis of £0.702m (report 155/15 refers). The actual underspend of £0.724m at the year end shows an increase in the underspend of £0.022m from the previously reported position.

The more significant movements which have arisen when comparing actual expenditure to the outturns noted in reports 151/15 and 173/15 include:
