Step 1

Are there any statutory legal requirements affecting this proposal? If so please describe.

The Marriage (Scotland) Act 1977 permits a registrar to solemnise a civil marriage in his registration office or at an appropriate place in the registration district of the authorised registrar. The Registration Service has three offices (in Montrose, Arbroath and Forfar) and each office has a room set aside and furnished for conducting civil marriages, partnership registrations and private citizenship ceremonies. In accordance with the Council's accommodation strategy, work is ongoing to co-locate this Service within other Council premises. Issues may arise in respect of the availability of accommodation to conduct the ceremonies referred to above but it is not thought that these issues are insurmountable.

It is against this background that consideration has been given to using the Canmore Room for conducting civil marriages, partnership registrations and private citizenship ceremonies. The use of the Canmore Room will reduce the accommodation requirements of a co-located Forfar Registration Office. In addition, it is considered that the location and suitability of the Canmore Room for conducting these types of ceremonies may increase the number of persons wishing to use the Registration Service which could result in additional revenue. The Registration Service has been seeking to increase revenue by promoting the use of its services at local marriage fairs and by introducing additional services (such as Renewal of Marriage Vows and Baby Naming Ceremonies). The Registration Service is also in the process of preparing a brochure advertising the services and facilities available in Angus.

If the Committee is minded to permit the use of the Canmore Room for conducting civil marriages, partnership registrations and private citizenship ceremonies, then it must prohibit the use of the Room for conducting religious or belief ceremonies. The National Registers of Scotland is responsible for the arrangements for registering births, deaths, marriages and civil partnerships in Scotland. They have been clear that if premises are to be designated as a "registration office" for the purposes of the Marriage (Scotland) Act 1977 then the premises cannot be used for conducting religious or belief. It is understood that this is required to preserve the distinction between religious marriage ceremonies and the civil marriage ceremonies performed by the Registration Service. It is not known that the Canmore Room has ever been used for such ceremonies (religious or otherwise).

If yes please give details. The Council currently have three marriage rooms in Angus which are solely used for Civil Marriage and Partnership Registrations. These Rooms cannot be used for religious or belief based marriage ceremonies. The proposal will make available an additional service which should generate income. The Canmore Room will be treated exactly the same as the current three marriage rooms in Angus. It should also be noted that the Registration Service cannot perform religious or belief based marriage ceremonies. The use of the Canmore Room and the required restriction is a requirement of legislation. Advice has been obtained from the National Records of Scotland. This issue turns on whether the Room is used

by the public for a variety of purposes. The Canmore Room is not available for booking by the public and is used solely in connection with Council or Council related functions.
