ANGUS COUNCIL COMMUNITY GRANT SCHEME

REPORT BY CHIEF EXECUTIVE

ABSTRACT

This Report informs the Policy and Resources Committee of applications to Angus Council in 2015/16 of £1,000 or less submitted and/or approved since 26 May 2015. It also seeks approval of grant applications of over £1,000 recommended for approval since 26 May 2015.

4. FINANCIAL IMPLICATIONS

4.1 Angus Council Community Grant Scheme - 2015/16

The base provision for the Angus Council Community Grant Scheme contained within the 2015/16 revenue budget totals £67,248 comprising Communities - £7,000 and Other Services revenue budget - £51,000. This base provision has been augmented by the 100% carry forward amount from 2014/15 of £9,248 being the balance of resources available from the Grant Scheme.

- 4.2 The amount submitted for approval in this Report for 2015/16 totals £25,541.04 (£3,845.44 and £21,695.60). The recommended amount of £25,541.04 combined with other grant approvals in 2015/16 of £19,008.40 (this varies from the figure reported in May as the recommended grant to Art Moves was increased by the committee which brings the total commitment in 2015/16 to £44,549.44.
- 4.3 From 1 April 2015 until 31 March 2016 or until the funding is fully subscribed there is a ringfenced amount of £15,000 available for Food and Drink projects in support of the Scottish Government Focus Years programme as outlined in report 110/15. Since 26 May £1,947.00 has been awarded to projects leaving a remaining £13,053 for the remainder of the year.
- 4.4 An uncommitted balance of £20,751.56 is available to fund grant applications for the remainder of 2015/16 which includes the £13,053 remaining for food and drink activity.
