ANGUS COUNCIL COMMUNITY GRANT SCHEME

REPORT BY CHIEF EXECUTIVE

ABSTRACT

This Report informs the Policy and Resources Committee of applications to Angus Council in 2016/17 of £1,000 or less submitted and/or approved since 30 August 2016. It also seeks approval of grant applications of over £1,000 recommended for approval since 30 August 2016.

1. **RECOMMENDATION(S)**

3. CURRENT POSITION

3.1 The Angus Council Community Grant Scheme in its current guise has been operating since 2009 and has received or approved 615 applications. This has provided over £800,000 of support to 435 groups within the Angus community.

It is the view of the assessors that as this project relates purely to the sporting activities of the club and is encouraging youth engagement and improving gender equality within the sport it would be eligible under the 'benefiting the wider community' clause.	£5,000	Sport	Club are installing additional changing facilities. Funding requested for part project costs of ground preparation, slabs and wall for installation for new facilities. Club has been working to encourage more young people into the sport. In order to make their youth programme as effective and sustainable as possible, they must ensure that club facilities are suitable to welcome, accommodate and inspire young people to take up the sport for life. At present, there is no separate accommodation for girls and boys who want to play - there should be changing space for both, so are looking to fit additional changing facilities, to include storage and upgraded toilet provision.	The aim of the project is to provide suitable changing facilities to encourage and enable the participation of young people in the sport of bowling. The Club recognises that to ensure sustainability, they need to encourage younger people into the sport; providing appropriate changing facilities will assist with this. The Club has engaged with local schools, Active Schools Co-ordinators, sports development team and other local bowling clubs to realise this project. The Project clearly fits with the themes of bringing people together and increasing involvement. It enhances inter- generational work and addresses equality agenda to increase membership including to those who have physical support needs. The Club has requested £5,000 from ACCGS which represents less than half the total project value (total value £13,325). The Club intends to apply for other grants and fundraise for the remainder. Grant Recommended subject to condition below £5,000.00 The club to ensure proposed design of changing facilities for children and young people bearing in mind the need for safety and privacy. Child protection is of paramount concern.

7. FINANCIAL IMPLICATIONS

7.1 Angus Council Community Grant Scheme - 2016/17

The base provision for the Angus Council Community Grant Scheme contained within the 2016/17 revenue budget totals £58,000 comprising Communities - £7,000 and Other Services revenue budget - £51,000. Included in this amount from 1 April 2016 until 31 March 2017 or until the funding is fully subscribed there is a ring-fenced amount of £15,000 available for Innovation, Architecture and Design projects in support of the Scottish Government Focus Years programme as outlined in report 110/15.7.2

- 7.2 The amount submitted for approval in this Report for 2016/17 totals £6,799.14, (£1,799.14 and £5,000 The amount recommended for approval in this report for ACCGS of £6,799.14 combined with other grant approvals in 2016/17 of £25,357.32 brings the total commitment in 2016/17 to £32,156.46.
- 7.3 The amount recommended for approval in this report of £3,699.23 for Architecture, Innovation and Design projects leaves a remaining balance of £6,317.69 for the rest of the year.
- 7.4 The amount submitted in this report for 2016/17 totals £10,498.37 (£6,799.14 and £3,699.23)
- 7.5 The combined total of grants awards for 2016/17 equals £40,838.77 leaving a total uncommitted balance of £17,161.23 available to fund grant applications for the remainder of 2016/17.
