This proposal has been developed in specific communities where part-time early learning and childcare provision does not fully support the needs of that community. Parents and carers in some rural communities have so far to travel to their local nursery that they have no option but to wait at the school until; the session ends. Other parents who are trying to return to work find they cannot accept employment because they do not have adequate childcare in their locality. This proposal offers additional childcare hours at a fair price to help these families back to work.
