TAXI FARE REVIEW
REPORT BY SHEONA C HUNTER HEAD OF LEGAL AND DEMOCRATIC SERVICES


#### Abstract

This Report relates to the proposed review of the taxi fare structure for Angus.


## 1. RECOMMENDATION

It is recommended that the Committee;-
(i) considers the taxi fare review options contained in Appendices $\mathbf{1}$ and 2 to this report;
(ii) determines whether or not to adopt one of the proposed options or adopt an amended option and instruct the Head of Legal and Democratic Services to advertise the adopted option;
(iii) delegates authority to the Head of Legal and Democratic Services to implement the adopted option as soon as possible, in consultation with Police Scotland, in the event that no representations are received within one month of the date of advertising of the adoption option; and
(iv) notes that any recommended increase represents the maximum fare chargeable by taxi drivers and is not a compulsory fare.

## 2. ALIGNMENT TO THE ANGUS COMMUNITY PLAN/SINGLE OUTCOME AGREEMENT/CORPORATE PLAN

## 3. BACKGROUND

3.1 In terms of the Civic Government (Scotland) Act 1982, the local authority requires to complete a review of fares for the hire of taxis and for all other charges in connection with the hire of taxis, within 18 months of the last review. The last review was initiated on 6 August 2015.
3.2 The current review was initiated on 16 December 2016. All taxi operators licensed in Angus were written to and their proposals for any changes were requested no later than 16 January 2017. Eight responses were received from Operators which, combined, provided four proposals. They are shown in the Appendices attached. The Committee will see that the proposals represent no change in the current fares charges or an increase of up to $43 \%$ for tariff 1 .
3.3 Appendix 2 has been prepared to provide members with an indication of the approximate percentage increases in respect of the options submitted. Sample journey lengths of 1, 2, $3,5,10$ and 15 miles have been used to calculate the percentage increases.
3.4 If the Committee determines to amend the current fare structure, then the proposed amended fare structure will be published in the "Courier". In publishing the proposed amended fare structure, the Council must:-
(I) set out the proposed amended fare structure;
(ii) explain the effect of the proposed amended fare structure;
(iii) propose a date on which the proposed amended fare structure is to come into effect; and
(iv) state that any person may make representations in writing until the relevant date.
3.5 The relevant date is a date specified by the licensing authority falling at least one month after the first publication by the authority of the proposed scales.
3.6 In the event that, following publication of the proposed amended fare structure, no representations are received within the period for representations to be made, then authority is sought to permit the Head of Legal and Democratic Services to implement the proposed amended fare structure in consultation with Police Scotland. The Committee is asked to note that there is a requirement to test the metering arrangements of taxis to ensure that the meters are correctly calibrated to the amended fare structure. This work is undertaken by Dundee City Council on behalf of the Council and is a resource intensive exercise.
3.7 In the event that representations to the proposed taxi fare review are received then a further report will be submitted to this Committee to consider those representations.

## 4. CONCLUSION

The Committee is asked to note the responses obtained from the consultation exercise undertaken with taxi operators. Committee is also asked to determine whether or not to adopt one of the proposed options or adopt an amended option and instruct the Head of Legal and Democratic Services to advertise the adopted option.
