#### REPORT BY THE HEAD OF TECHNICAL AND PROPERTY SERVICES

#### ABSTRACT

This report seeks Committee approval for community based Forfar and Montrose Common Good funded projects.

#### 1. **RECOMMENDATIONS**

1.1 It is recommended that the Committee:

(i) approve the requested funding for projects from both Forfar (Strathmore Rugby Club) and Montrose (Montrose Tennis Club) Common Good Funds respectively as set out in this report, and;

(ii) homologate the decision of the Convener of the Policy and Resources Committee and Head of Corporate Improvement and Finance to pay a grant to Forfar Small Bore Rifle Club from Forfar Common Good Fund, and;

(iii) note the revised Forfar and Montrose Common Good Funds revenue fund balance as at 31 March 2015 which has been updated to reflect the contents of this report.

  - Kirriemuir
  - Montrose

#### 4. PROPOSALS

4.1 Three additional projects requesting funding; two from Forfar Common Good and one from Montrose Common Good have been submitted from external organisations. These projects has been considered and agreed with local elected members as part of the approval process. The projects are set out within this report for formal approval by this committee.

4.2 Details of the individual projects for which formal approval is sought are contained in Appendix 1 in this report. Please note there are no current additional funding requests for the Arbroath, Brechin, and Kirriemuir Common Good Funds. Further reports will be presented to Committee as and when necessary.
