BACKGROUND TO THIS REPORT

As from April 2013, the Police and Fire Reform (Scotland) Act 2012 has required Police Scotland to produce and publish a Local Policing Plan (LPP) for each local authority area. The LPP clearly sets out the policing priorities for Angus.

Performance in relation to the identified policing priorities is monitored and reviewed internally on a weekly basis. Quarterly reports are produced to allow scrutiny by Angus Council Police and Fire and Rescue Sub Committee. This report covers the period from April 2014 to 31 March 2015.

Data provided in this report is for information purposes to allow Board Members to conduct their scrutiny responsibilities.

This report will make reference to crime groupings. Groups 1-4 refer to an amalgamation of four crime groups. They are Group 1, consisting of violent crime; Group 2 covering sexual offences; Group 3 covers a wide range of crimes of dishonesty; and Group 4 includes vandalism, fire-raising and malicious mischief.

It should be noted that although this data cover the financial year of 2014/15, this data should not be considered as yearend statistics. The Scottish Government will release yearend statistics at a later date.

Serious and Organised Crime


Tackling Serious and Organised Crime Groups (SOCGs) remains a key focus in Angus.

We have continued to increase our utilisation of the Proceeds of Crime Act (POCA) to deprive criminal groups of millions of pounds each year.

Local Officers continue to be assisted by national resources in carrying out Operation Jackal. Operation Jackal aims to dismantle and disrupt criminal business structures by capturing and then exploiting financial intelligence in relation to SOCGs.

Angus officers continue to target groups that profit from the supply and distribution of Class A drugs including Diamorphine (Heroin). Our shifting focus to arrest high level targets is reflected in the slight decrease in the total number of detections for drugs supply, production and cultivation.

Public Protection and Safety

The upward spike in crimes of violence, discussed in previous reports, has unfortunately continued to be evidenced in the final reporting period of this year. The total number of crimes of violence has increased by 46.4% in comparison to the same period last year.

Angus has traditionally been accustomed to low level of serious assaults and robberies and as such increases represent large percentile changes. This is particularly true with regards the percentile increase for offences of robbery.

As previously acknowledged, this can partly be attributed to a broadening of the circumstances that would be recorded as a robbery. Police Scotland and Angus Local Policing Area are committed to the ethical recording of crime and as such are guided by the Scottish Crime Recording Standards. This hopefully will allow the committee members to view this increase in context with the broad circumstances that encapsulate a robbery.

It is acknowledged however that Angus Local Policing Area must tackle this increase and as such work continues to be undertaken with the Angus Violence Reduction Plan.

There has been a slight increase in crimes of indecency with 257 incidents being recorded last year and 264 recorded this year.

The detection rate for instances of rape has dropped by 18% in comparison to last year. Police Scotland and Angus Local Policing Area undertake all possible investigative measures to detect Group 2 crimes and bring offenders to justice. It must however be acknowledged that a historic incident presents less avenues of investigation for officers and often despite our best efforts the sufficiency of evidence to detect and report such incidents is not reached.


Going forward, officers will continue to adopt a victim centered approach and work closely with our partners to support the victims of such crimes.







Domestic Bail Offences - Total Detections

Road Safety

As always, the strategic priority is keeping people safe on the roads of Angus.

Road casualty statistics for the reporting period have shown significant reductions.

Crucially there has been a 39.6% reduction in the number of people seriously injured on the roads of Angus. The number of children seriously injured has dropped from 5 in 2013/14 to 2 in 2014/15. This represents a 40% decrease.


The number of people slightly injured also has decreased from 145 in 2013/14 to 127 in 2014/15.

The Committee will note that the significant reduction in formal prosecution measures, which has been discussed in previous reports, is again evidenced. Tayside Division and Angus Local Policing Area recognise community concerns and feel local law enforcement should deliver meaningful outcomes for road safety. During 2014/15 there has been a continuing increase in discretionary warnings and education rather than blanket policies of enforcement.

This approach has seen us engage with more drivers and continue to increase the profile of road safety issues. During the last quarter, local officers have taken part in Operation Zenith, which aims to raise awareness amongst all road users about motorcycle safety. This is particularly significant to Angus as its picturesque country roads attract an influx of motorcyclist during the spring and summer months.

Antisocial Behaviour

Antisocial behaviour is comprised of a variety of offences, including vandalism, noise nuisance, and various other offences that cause a negative impact on the communities of Angus.

This reporting period has seen a 12.6% decrease in the number of complaints of disorder in comparison to the same period last year. Vandalism and malicious mischief has also decreased, albeit by a lesser amount.


Angus Local Policing Area continues to utilise officers in specific deployments of non front line officers in Campaign Against Violence days. These deployments focus on curbing antisocial behaviour and targeting known hotspots and help by bolstering resources during peak times.

Police have worked closely with our partners and the local community to prevent businesses that intend to sell and distribute New Psychoactive Substances (NPS) from opening premises and gaining a foothold in Angus. In recent months these efforts have been widely publicised in local media and Police will continue with efforts to lead and support campaigns to prevent the sale of NPS and curb the antisocial behaviour that they bring.


Looking forward into spring and summer, Police will continue to work closely with our partners to reduce antisocial behaviour during the school holidays and other key periods.

Police will continue to support the influx of visitors to Angus in the summer months and aim to ensure that antisocial behaviour is robustly tackled.

Theft and Scams

The number of instances of theft by housebreaking (which includes dwelling houses, garage sheds, retail and non occupied premises) has decreased by 17.5%

This represents 49 fewer houses being broken into within Angus.

Detection rates for housebreaking have also increased by 3.8%.


Theft by shoplifting has again shown a significant decrease in the number of recorded incidents. This year has shown 101 fewer incidents which represents a decrease of 17.5%.

Proactive work by officers coupled with increase shop security and crime prevention tactics will continue to support this downward trend.

Operation Monarda continues to raise awareness with regards doorstep crime. Working with our partners is key in ensuring that the most vulnerable groups of our community are aware of the dangers of bogus workmen, scammers and fraudsters.

Going forward our officers will continue to support home owners and retail premises throughout the spring and summer, by offering crime prevention advice and conducting robust enquiry should crime occur.
