# CONTRACTS AWARDED AND EXEMPTIONS APPROVED UNDER DELEGATED POWERS: 1 JUNE 2013 TO 30 NOVEMBER 2013 – SOCIAL WORK AND HEALTH

#### REPORT BY HEAD OF QUALITY AND PERFORMANCE

#### **ABSTRACT**

This report advises members of the contracts awarded and the Financial Regulations exemptions granted by the Strategic Director - People under delegated powers for the period from 1 June 2013 to 30 November 2013. This report is required by Financial Regulations 16.8.2 and 16.24.13.

#### 1 RECOMMENDATION

1.1 It is recommended that the Social Work and Health Committee notes the contents of this report.

#### 2 BACKGROUND

- 2.1 Financial Regulation 16.8.2 provides that "It is the responsibility of all Chief Officers to ensure that all delegated contract award decisions ... made are subsequently reported to the appropriate Committee at least every six months." This applies to both contracts of a value up to and including £50,000 for supplies and services and £500,000 for works where standing delegated authority exists under Financial Regulations Appendix 1 and to contracts above those values where project-specific procurement authority was approved by Committee.
- 2.2 "Exemptions" are departures from the normal requirements under Financial Regulations Section 16 to award contracts competitively where a justifiable reason exists under Financial Regulation 16.24.10 for that exemption. Financial Regulation 16.24.13 provides that "All Chief Officers ... will maintain a register of all exemptions granted by them under their respective delegated powers. Chief Officers are responsible for ensuring that exemptions actioned by them under delegated powers are reported to the appropriate committee at least every six months." Chief Officers may approve exemptions of a value up to and including £50,000 and the Exemptions Co-ordinator may approve them up to and including £100,000. Beyond that value requires Committee authority.
- 2.4 This report sets out the contracts granted and exemptions approved within Social Work and Health under delegated powers for the period from 1 June 2013 to 30 November 2013.

### 3 DETAILS OF CONTRACTS AWARDED AND EXEMPTIONS APPROVED

- 3.1 **Appendix 1** to this report sets, out in tabulated form, the contracts awarded for Social Work and Health under delegated powers (either standing or as granted by Committee) within the relevant period.
- 3.2 **Appendix 2** to this report sets, out in tabulated form, the exemption requests approved for Social Work and Health under delegated powers within the relevant period.
- 3.3 The purpose of this report is to allow elected members to scrutinise the activity reported.

#### 4 RISKS

This report does not require any specific risk issues to be addressed.

#### 5 FINANCIAL IMPLICATIONS

There are no financial implications arising as a consequence of this report. Contracts awarded have been met within budget by the relevant chief officers at the time of application.
