Angus Council agrees with the proposals for membership powers and proceedings of Integration Joint Boards identified in the draft regulations.

Local consideration will have to be given to the term of appointment of chair and vice chair, which it is suggested in the draft regulations is carried out on a three year basis, as elected members usually serve a term of four years in office. Two thirds of the membership as a quorum may prove challenging for some Integration Authorities and it may be that local arrangements are established to allow substitutes for members to ensure representation and continuity of meetings.

Angus Council is of the view that the form which should be prescribed should relate to the prescribed content contained within the draft regulations. This will allow a degree of comparison of certain elements of performance across Scotland while still identifying where local action is improving outcomes at a local level.

Angus Council recognises that both parent bodies have robust performance arrangements in place including Revenue Budget, Health and Safety, Employee data and Corporate Risk Registers. Close links will be made with Community Planning to develop working arrangements on the delivery and reporting on the national health and wellbeing outcomes.

On Page 63 the last bullet point states that the draft regulations will require Integration Authorities to report on:

• The extent to which they have moved resources from institutional to community based care and support, by reference to changes in the proportion of the budget spent on each type of care and support.

Angus Council wishes to note that compliance with this requirement in reports will reflect new/changing demographics and demand and the impact this will have or will have had on the transfer of resources.

It is suggested that arrangements for external scrutiny of performance reports should be considered within this section of the draft regulations and within future guidance.
