EAST SEATON FARM, ARBROATH

REPORT BY THE STRATEGIC DIRECTOR - COMMUNITIES

ABSTRACT

This report deals with an application to amend the temporary workers' caravan site licence at East Seaton Farm, Arbroath in order to to change the permitted operating period and increase the maximum number of caravans allowed on site.

1. **RECOMMENDATION(S)**

- 1.1 It is recommended that the Committee agree:
 - (i) that the temporary workers' caravan site licence be amended in order to allow a maximum number of 90 caravans on site; and
 - (ii) that the site operating period be changed to 1 January 30 November annually.

3. BACKGROUND

- 3.1 Application has been made to Angus Council on behalf of the site licence holder, Mr Lochart Porter, East Seaton Farm, Arbroath for an amendment to the existing temporary workers' caravan site licence for East Seaton Farm, Arbroath. The amendment would increase the maximum number of caravans that can be accommodated on site from 85 to 90 and see the operating period change to 1 January to 30 November (currently 1 May to 31 October).
- 3.2 The site operates with the benefit of appropriate planning permission and it is confirmed that the above amendments would not result in any breach of the current planning consent.
- 3.3 A recent site inspection confirmed that the site complies with licence conditions and meets the "Model Standards" under the Caravan Site and Control of Development Act, 1960.

4. DETERMINATION OF LICENCE

4.1 On the basis that the site meets the requirements of "Model Standards" in compliance with The Caravan Sites and Control of Development Act, 1960 and that the necessary planning consents are in place, this application to amend the licence should be granted.
