REVIEW OF CHARGES WITHIN COMMUNITIES DIRECTORATE

REPORT BY ALAN McKEOWN, STRATEGIC DIRECTOR - COMMUNITIES

ABSTRACT

This report sets out proposals for the charges to be levied by service areas in Communities for the financial year 2016-17.

1. RECOMMENDATIONS

It is recommended that the Council:

- (i) Notes that that this report has been prepared on the basis that the percentage increases for charges have, in the main, been applied at a rate of an average 2.5% rounded where appropriate;
- (ii) Approves the pricing structures as contained within appendices 1 to 4;
- (iii) Agrees that the charges are effective from 1 April 2016, or the start of any seasonal operations;
- (iv) Approves a mid-term review of charges. This will be reported to committee for implementation in September/October 2016, if any changes recommended.

2. ALIGNMENT TO THE ANGUS COMMUNITY PLAN/SINGLE OUTCOME AGREEMENT/CORPORATE PLAN

This report contributes to all of the local outcomes contained within the Angus Community Plan and Single Outcome Agreement 2013-2016.

3. BACKGROUND

- 3.1 The charges covered by this report are reviewed continuously by each business unit throughout the financial year. All amendments to charges are reported to Committee on an annual basis as part of the budget setting process. The last annual review of charges was reported to Angus Council Committee on 12 February 2015. (Report 56/15 refers)
- 3.2 The review of Commercial Waste charges was been reported to Communities Committee on 17 November 2015 to allow implementation of charges from 1 January 2016. (Report 444/15 refers)
- 3.3 The review of Council House rents was carried out by the Housing Division with the rent setting meeting having taken place on 09 February 2016. (Report 46/16 refers)
- 3.4 The review of charges for 2016/17 has been carried out as part of the budget setting process and the percentage increase, has in the main, been standardised across the divisions in Communities to 2.5%, before accounting for VAT and Landfill Tax., where applicable. The charging structure attached at Appendices 1, 2, 3 and 4 has been prepared on the basis of this average percentage increase, rounded up to the nearest 10p after the application of VAT and Landfill Tax, where applicable.
- 3.5 Following the formation of Angus Alive (the Culture and Leisure Trust) from 1 December 2015, Angus Council will no longer set the charges for the services which have transferred to the Trust.

- 3.6 The Council recovered possession of South Links Holiday Park, Montrose from September 2015 and have been working to secure the future use of the site as a holiday park for static and touring caravans for 11 months of the year, closing in February each year.
- 3.7 There is now a need to set the rental levels for 2016-17, although it should be noted that the Council gave commitment to retain the 11 month static rentals at the same level as 2015/16 in the sum of £1,950 per annum, exclusive of VAT.
- 3.8 The touring rentals for caravans and tents have been set in line with similar letting sites in Scotland. Details are given in appendix 4.

4. PROPOSED CHARGES

The proposals summarised in the table below would come into force on 1 April 2016 or at commencement of any seasonal operation.

5. FINANCIAL IMPLICATIONS

- 5.1 It is estimated that the increased charges for Environmental and Consumer Protection, as detailed in appendix 1, will generate additional income of £12k.
- 5.2 It is estimated that the increased charges for Waste Management, as detailed in <u>appendix 1</u>, will generate additional income of £9k.
- 5.3 It is estimated that the increased charges for Parks Division, as detailed in <u>appendix 2</u>, will generate additional income of £9k.
- 5.4 It is estimated that the increased charges for Roads Division, as detailed in appendix 3, will generate additional income of £7k.
- 5.5 The charges for Blue Badge Applications, as detailed in <u>appendix 4</u>, are being retained at the same level for 2016/17. It is anticipated the level of applications will remain constant giving no change to income levels.
- 5.6 It is estimated that the new charges for the pitch rentals at South Links Holiday Park, as detailed in <u>appendix 4</u>, will generate income to meet the operating budget.

5.7 The additional income at 5.1, 5.2, 5.3 and 5.4, totalling £37k has been accounted for within the Communities Directorate 2016/17 revenue budget proposals.

6. EQUALITIES IMPLICATIONS

The issues in this report have been the subject of consideration from an equalities perspective (as required by legislation). An equalities impact assessment is not required.
