REVIEW OF FEES AND ALLOWANCES WITHIN CHILDREN AND LEARNING DIRECTORATE FOR 2016-2017

REPORT BY MARGO WILLIAMSON, STRATEGIC DIRECTOR – PEOPLE

ABSTRACT

This report sets out proposals for the fees and allowances within the Children and Learning Directorate for 2016-2017.

1. **RECOMMENDATION**

It is recommended that the Council approves the rates specified in appendix 1, with effect from 04 April 2016.

2. INTRODUCTION

Each year Angus Council reviews the fees and allowances for specific services in line with statutory requirements, guidance and Angus Council policy. This report proposes the rates for 2016-2017 in relation to the Children and Learning Directorate.

3. PROPOSAL

Allowances

- 3.1 **Fostering allowances:** Foster carers receive a 'fostering allowance' to cover the costs of caring for a child and a 'carer's allowance' which is essentially a fee for the service they provide. In April 2010 it was agreed that fostering allowances in Angus should be linked to the national rate established and revised each year by 'The Fostering Network' (TFN). The TFN rates were used widely by independent fostering agencies and by the majority of Local Authorities. The Fostering Network has recently announced that it will no longer be making recommendations from the beginning of the financial year 2016-2017. This decision followed on from an announcement by the Scottish Government that it will be making national recommendations in the near future and is currently undertaking research to help inform its decisions on this matter. In the absence of a specific national recommendation, it is proposed that fostering allowances by 1.5%.
- 3.2 **Carers' allowances**: The previous TFN recommendation in relation to carer allowances was that these should be linked to salaries paid to staff. Whilst no government guidance is available yet, a pay increase of 1% of staff has been agreed for 2016/17 and it is proposed that we stick to the previous arrangement and reflect this in the fees paid to carers.
- 3.3 **Other expenses and allowances:** It is proposed that the recommended 1.5% increase is applied to all other allowances and expenses including those paid for kinship, residence and adoption allowances, inclusive of child benefit rates. The exceptions are the personal allowances paid to care leavers. These allowances are linked to the level of benefit payments set by the DWP and the proposed rates are based on the DWP 2016-2017 rates.
- 3.4 **Community childminders**: Community childminders are registered by the Care Inspectorate but provided with additional training and support by Angus Council to offer an enhanced level of service to vulnerable children. This includes the provision of short term day care and overnight respite placements to children with disabilities. Following a review of the service the

rates were significantly increased in April 2014 in order to promote this scheme which provides an excellent resource for these children at a very reasonable cost. It is proposed that these rates are linked to staff salaries in the same way as the carers' allowances. Accordingly, we propose that these are raised by 1% for 2016-2017.

Fees

- 3.5 School Meals: School meals are provided on a contract basis from Tayside Contracts. Any income received from meals is payable to Tayside Contracts and they set the charges for meals.
- 3.6 Instrumental Instruction: The Instrumental Music Service (IMS) provides Angus children with opportunities to learn a musical instrument and provide performing platforms at school and regional level to develop their musical skills and express their music identities. The standard charge is currently £210.00. It is proposed to increase this charge by 5% to £231.00.

4. RISK

This report does not require any specific risk issues to be addressed.

5. FINANCIAL IMPLICATIONS

The additional cost of implementing the proposed increases is estimated to be £34,000. Provision for these increases has been made within the 2016/17 budget.

6. HUMAN RIGHTS IMPLICATIONS

There are no human rights implications arising from the recommendation contained in this report.

7. EQUALITIES IMPLICATIONS

The issues in this report have been the subject of consideration from an equalities perspective (as required by legislation). An equalities impact assessment is not required.

8. SINGLE OUTCOME AGREEMENT

This report contributes to the following local outcomes contained within the Angus Single Outcome Agreement:

Nurtured: Children and young people in Angus will live within a supportive family setting with additional assistance if required, or where this is not possible, within another care setting ensuring a positive and rewarding childhood experience (National Outcome 5).

9. CONCLUSION

This report sets out proposals for a revision of fees and allowances within the Children and Learning Directorate for 2016 -2017.
