## 4. LOGISTICS HUB - UPDATE

Report 166/14 was submitted to Social Work and Health Committee on 8 April 2014 recommending the discontinuation of the Logistics Hub (a facility which would have encompassed the AJELS equipment store, the community laundry and the community meals base) because the cheapest cost estimate for the development considerably exceeded the available funds. This was approved by Committee and the plan to take the component parts forward as individual developments was agreed. It was noted that an options appraisal would be carried out for each of these elements and reported back to Committee.

This work is ongoing but is taking longer than originally anticipated, due to the complex interplay of accommodation issues, cost, single or multiple purpose premises, and considerations around a possible partnership approach with NHS Tayside for the equipment store.

When completed, the options appraisal will be submitted to the first available Social Work and Health Committee. This is likely to be in the autumn of 2014.
