KEPTIE STREET, ARBROATH – PEDESTRIAN CROSSING

REPORT BY THE HEAD OF TECHNICAL AND PROPERTY SERVICES

ABSTRACT

This report re-presents the deferred Report No 264/17 following the site visit by Communities Committee to the potential pedestrian crossing points on Keptie Street, Arbroath.

1. RECOMMENDATIONS

It is recommended that the Committee:

- (i) notes that a site meeting was held at Keptie Street on 7 October 2017;
- (ii) notes previous investigations and consultations undertaken following the request for a signal controlled pedestrian crossing on Keptie Street, Arbroath;
- (iii) notes the current difficulties which pedestrians, particularly the elderly, encounter when crossing Keptie Street, Arbroath;
- (iv) notes the results of the most recent site surveys carried out following the request to reinvestigate the possibility of installing a signal controlled pedestrian crossing on Keptie Street, Arbroath;
- (v) determine whether or not a pedestrian crossing shall be provided between Helen Street and Garden Street or between Garden Street and Lochlands Street; and
- (vi) determine whether or not a dropped kerb crossing point with associated footway build outs shall be provided near Garden Street;

2. ALIGNMENT TO THE ANGUS COMMUNITY PLAN/SINGLE OUTCOME AGREEMENT/CORPORATE PLAN

This report contributes to the following local outcomes contained within the Angus Community Plan and Single Outcome Agreement 2013-2016:

- Our communities are prosperous and fair
- Our communities are safe and strong
- Our communities are sustainable

3. DETAILS

With reference to Article 12 of the minute of the meeting of the Communities Committee of 15 August 2017, which deferred Report No 264/17 to enable a site visit to take place to facilitate members' understanding of the various proposals for a crossing, to which all members of the Committee would be invited, the requested meeting was held at Keptie Street on 7 October 2017 with eight member of the Committee in attendance.

5. PROPOSALS

The Committee are asked to now consider Report No 264/17 and to consider if any further consultation should be undertaken. If Committee are minded to consult it is suggested that

this could be through a letter drop to those affected premises in the vicinity of the potential crossings; an on-street sample survey of users undertaken over a two day period, including a Saturday; letter drop to local sheltered housing; and use of the council's Have Your Say website

6. FINANCIAL IMPLICATIONS

The financial implications of the proposed crossings are as set out in Report No 264/17, noting that at this stage of the financial year the construction of a potential crossing is likely to continue in part into the 2018/19 financial year and be funded from roads capital funding in 2018/19.

The financial implications of the consultation are estimated at £1000 for the surveys and results analysis and would be contained within the Roads revenue budget for 2017/18.
