5. MOTIONS IN TERMS OF STANDING ORDER 25(1)

(i) Council Representation on Carnoustie Golf Links Management Committee

A motion has been received from Councillor Cheape relating to the membership of CGLMC Limited (Carnoustie Golf Links Charitable Body). Members are advised that the Articles of Association of the company entitle Angus Council to nominate three persons to be Directors of the Company. They do not specify who or how those members should be chosen. The Council agenda of 16 May 2017 erroneously stated that those members were to be either the Leader of the Council or Convenor of the Communities Committee, one non administration member representing Ward 5 and the

Chief Executive (or nominee). The Head of Legal & Democratic Services therefore wishes to make it clear that membership of the Board of CGLMC Ltd is **not** restricted as previously stated.

Cllr Cheape has submitted the following motion:

- 1) That the Directors appointed by Angus Council to Carnoustie Golf Links Management Committee be drawn solely from Ward 5 (excluding the one officer appointment); and
- 2) Consequently, this Council re-visits the appointments made to CGLMC at the statutory meeting on 16th May.

(ii) Member/Officer Group on the Effects of Brexit

Cllr Devine has submitted the following motion:

"Council believes that it would be sensible and timely to set up an officer group to consider the effects which BREXIT is likely to have on Angus Council and the economy of Angus. Several other councils have already taken this step in order to be prepared to take decisions based on up-to-date information, as it becomes available, rather than wait until the last minute. It would be expected that reports would be brought forward to appropriate committees and/or Council.

Issues to be addressed should include:

Availability of European funding Changes in regulations e.g.: procurement Employee availability in public sector e.g.: care homes, NHS, IT Employee availability in private sector e.g.: agriculture, care homes, college, hospitality and construction industries

The above list is not exclusive."

(iii) Female Genital Mutilation

Cllr Sturrock has submitted the following motion:

"This Council forwards written communication to the Scottish Government requesting that the current laws as applicable to Scottish Law in this area are strengthened to reflect the recent measures as introduced in England and Wales."
