4. GENERAL DATA PROTECTION REGULATIONS (GDPR) UPDATE

Members are asked to note that since the inception of the IJB, legal advice has been that the IJB does not require to register with the Information Commissioners Office. 11 of the 31 IJB's across Scotland have, however, chosen to register. There are various reasons for this, including the nature of their Integration scheme arrangements, the belief that it is a requirement as the IJB holds personal information on IJB members, and a tendency towards voluntary registration. In the light of this, the emerging guidance on the GDPR, and the passage of the Data Protection Bill Legal Services have reviewed the position and have concluded that for a number of reasons including processing around consultation activities the IJB ought to register with the Information Commissioners Office. It is acknowledged that the amount of personal data controlled and/or processed by the IJB will be relatively small compared with the local authority and NHS. However, the primary outcome of this conclusion is that it will be necessary for the IJB to appoint a data protection officer to govern the organisation's use of data. This is consistent with the approach outlined in the report to the IJB of 21 February 2018 (Changes to Statutory Information Governance Requirements). Additionally, work is progressing on the GDPR implementation plan, including the development of a records management plan and a review of the data sharing arrangement between NHST, AC, P&K and Dundee Councils. To support implementation of GDPR, development sessions have been organised for staff. The Partnership's Senior Leadership Team received training on 29 March 2018.

5. THE CARERS (SCOTLAND) ACT 2016 UPDATE

Members will recall that at the last meeting of the IJB, it was agreed that a short term Working Group would be convened to consider the financial impact of implementation of the Carers Act for the IJB; this meeting has not yet taken place as the work being undertaken by Angus Council's Finance section to determine this "before and after" picture has not yet concluded.

6. INTEGRATION SCHEME UPDATE

The Board will recall that it considered a report in relation the implementation of the Carers (Scotland) Act 2016 (Report No. 20/18 refers). This report advised the Board of the requirement to amend the Integration Scheme between Angus Council and NHS Tayside to incorporate various new functions and duties contained in this Act into integration arrangements. The Board is asked to note that following the statutory process set out in Section 46 of the Public Bodies (Joint Working)(Scotland) Act 2014, the revised Integration Scheme was submitted for approval by the Scottish Ministers on 2 March 2018. The Scottish Ministers confirmed approval of the revised Integration Scheme on 3 April 2018.
