INFORMATION REPORT: COMMUNITY COUNCIL ELECTIONS

REPORT BY SERVICE LEADER - LEGAL AND DEMOCRATIC

ABSTRACT

This report sets out the arrangements for the Community Council elections due to be held later this year.

1. BACKGROUND

The last scheduled Community Council elections were held in 2015, postponed from 2014 due to the number of key electoral events which were held that year – Report 573/13 refers. It was agreed at that time that due to this postponement that Community Councillors term of office would be for a period of 3 years instead of the usual 4 year term to allow the election schedule to fall back into line with the Scheme of Establishment for Community Councils.

2. CURRENT POSITION

Arrangements are now underway to hold the Community Council elections in the autumn and the proceedings for these elections will be conducted in accordance with the following timetable (based on a contested poll being held) of events:
