#### **Functionality**

Although the school benefits from excellent internal and external facilities for teaching and learning, there is a lack of suitable spaces to host subjects such as music.

#### **Accessibility**

The location of the changing facilities is suitably placed, however, there is no external access to the changing facilities.

The gym hall is accessible for community use out with school hours but not during the school day. There is an inadequate number of spaces for the number of staff. Staff have no other option other than parking on Grange Road when there are no available spaces. This causes congestion in the morning as Grange Road is one of the main access routes to the A92.

#### **Environment Conditions**

Grange Primary School does not support any form of renewable energy.

#### **Fixed Furniture and Fittings**

Although the school has a wireless internet connection, it can be very temperamental. This limits the schools ability in supporting digital learning.

Lack of storage space is an issue throughout the entire school. The gym hall is cluttered with gym equipment, impeding on the delivery of certain sporting activities. Although the school has changing facilities, they remain unusable as they are currently being used to store gym equipment."

The changing facilities are currently being used to store gym equipment instead of being used for there intended purpose.

The reception area is lacking a holding area and a hatch. This space would enable visitors/parents entry into the building without allowing access into the entire school.

There are no resourced staff bases

#### **Accessibility**

Although the community space is fully accessible out with school hours, accessibility during school hours is limited due to it being used by the school.

#### Safety and Security

Although the school entrance has a secure entry system, there is no holding area or hatch. This means that once a parent/visitor gains access into the building, they then have the potential to access the entire school.

There are no areas to deal with sensitive matters or matters of confidentiality, other than the head teachers office. This is inadequate due to the head teachers office usually being occupied.

#### Functionality/Accessibility

Parking is inadequate during school hours due to insufficient numbers of spaces for staff. Staff have no other option other than parking on Grange Road when there are no available spaces. This causes congestion in the morning as Grange Road is one of the main access routes to the A92. Staff car park is small and has no turning circle/one way system. This has safety implications as well as causing congestion at the start and end of the school day. There is no external access to changing facilities.

#### **Environmental Conditions**

External lighting is in need of being upgraded due to lack of visibility.

#### Safety and Security

Parents use busy the staff car park as a drop off area due to there being no designated facilities for this. This is a major issue and has nearly resulted in pupils being knocked over. Perhaps the installation of a fob operated barrier should be considered."
