**ANGUS COUNCIL ANNUAL EDUCATION REPORT AND PLAN**

**REPORT BY PAULINE STEPHEN, CHIEF EDUCATION OFFICER**

**ABSTRACT**

The Standards in Scotland's Schools etc Act 2000 ("the 2000 Act"), as amended placed three new requirements on Education Authorities:

- To have due regard to the need to carry out functions relating to school education in a way designed to reduce inequalities of educational outcome experienced by pupils as a result of socio- economic disadvantage or otherwise.
- In discharging their duty under section 3(2) of the 2000 Act (to secure improvement in the quality of school education) to do so with a view to achieving the strategic priorities of the National Improvement Framework.
- The introduction of new annual planning and reporting duties; and annual school improvement planning.

The first annual education plan under this new requirement was agreed by Committee on 17<sup>th</sup> August 2017. This report summarises the progress made with that plan and sets out the new annual education plan for school session 2018 to 2019. A copy of the 2018 to 2019 Plan, if approved, will be sent to Scottish Ministers in line with statutory requirements.

**1. RECOMMENDATIONS**

It is recommended that the Children and Learning Committee:

- (i) Reviews the progress summarised in relation to Angus Annual Education Plan 2017/18 ("Angus Annual Education Report", appendix 1, section 1);
- (ii) Approves Angus Council's Annual Education Plan 2018/19, requests implementation of the plan and priorities (appendix 1, section 2), and instructs provision of the approved Annual Education Plan as soon as reasonably practicable to Scottish Ministers as required in terms of section 3F(2) of the 2000 Act;
- (iii) Notes that Angus Council's Annual Education Plan outlines improvement activity for the period 1st September 2018 to 31st August 2019;
- (iv) Requests the Chief Education Officer to ensure that an evaluation report on progress with Angus Council's Annual Education Plan, is presented to committee in September 2019;
- (v) Requests the Chief Education Officer to ensure that an information report on interim progress with Angus Council's Annual Education Plan, is presented to committee in January 2019.

**2. ALIGNMENT TO THE ANGUS LOCAL OUTCOMES IMPROVEMENT PLAN/CORPORATE PLAN**

### 3. BACKGROUND

3.1 Report 190/17, considered at Children and Learning Committee in June 2016, outlined new requirements for Education Authorities following amendments to the 2000 Act. There were three main new duties:

- Section 3B of the 2000 Act imposes duties on education authorities which are designed to promote a reduction in inequalities of educational outcome experienced by pupils as a result of socio-economic disadvantage or otherwise.
- Section 3D of the 2000 Act imposes a duty on education authorities, in discharging their duty under section 3(2) of the 2000 Act (to secure improvement in the quality of school education) to do so with a view to achieving the strategic priorities of the National Improvement Framework.
- Sections 3F, 3H and 6 of the 2000 Act impose duties on education authorities in relation to annual planning and reporting and annual school improvement planning.

3.2 The improvement activity of Angus schools and the Schools and Learning service is rooted in the strategic priorities outlined in the National Improvement Framework. These four strategic priorities are:

- Improvement in attainment, particularly in literacy and numeracy
- Closing the attainment gap between the most and least disadvantaged children and young people
- Improvement in children and young people's health and wellbeing
- Improvement in employability skills and sustained, positive school leaver destinations for all young people

3.3 The **Angus Annual Education Plan** must set out for the planning period:

- Steps proposed to reduce inequalities of outcome experienced by pupils as a result of socio-economic disadvantage or otherwise.
- The ways in which the education authority will seek and have regard to the views of the persons listed below and to provide any advice and support the authority thinks appropriate to those persons in relation to its consideration of decisions of a strategic nature about the carrying out of its school education functions. In terms of the legislation the following persons are specified:
  - (a) Head teachers
  - (b) Pupils
  - (c) Parents
  - (d) Trade unions representing teaching staff
  - (e) Voluntary organisations
  - (f) Any other personsAll as the Authority thinks appropriate.
- Steps to be taken in pursuance of the four priorities contained within the National Improvement Framework.
- Any educational benefits for pupils that the authority considers will result from taking all of these steps

### 4. CURRENT POSITION

4.1 The first Angus Annual Education Plan produced in response to these new requirements was approved in August 2017 (271/17). An interim progress report was considered by the Children and Learning Committee in January 2018 (1/18). The final review of actions set out in the Angus Annual Education Plan 17/18 is set out in appendix 1, section 1. The majority of actions have been completed or overtaken. Progress with this plan has been considered in conjunction with the range of evidence that indicates how well Angus' schools and the Schools and Learning service is performing. This includes:

- A range of performance information relating to attainment, exclusions, attendance, etc.
- The outcomes of Education Scotland and Care Inspectorate inspections
- Our validated self-evaluation (VSE) of the school improvement planning process
- Formal evaluations of aspects of service provision such as Pupil Equity Funding (PEF)

- 4.2 The analysis of our current performance indicates that we have made good progress in meeting the strategic priorities of the National Improvement Framework. Our well-developed self-evaluation processes however highlight where more or different work is needed. Some of our improvement activity will be progressed on a regional basis through our collaborative partnership working with Dundee, Perth and Kinross Councils, NHS Tayside and other partners. The educational improvement activity that relates to Angus specifically is outlined in our new Angus Annual Education Plan for school session 2018/19, outlined in appendix 1, section 2.

## **5. PROPOSALS**

A report on progress in relation to the first Angus Annual Education Plan and the strategic priorities in relation to the National Improvement Framework, as required by legislative amendment, is set out in appendix 1, section 1. The Plan for session 2018/19, highlights planned educational improvement activity for the period 1st September 2018 to 31st August 2019. It is proposed that this Plan is considered and approved by Children and Learning Committee and an evaluation report on progress with the Plan is brought before Committee in September 2019.
