VEHICLE LENGTH RESTRICTIONS ON ROADS – TANNAGE BRAE & KNOWEHEAD, KIRRIEMUIR

REPORT BY THE HEAD OF INFRASTUCTURE

ABSTRACT

This report recommends that a permanent Order be promoted to provide exemption for refuse collection vehicles to the current vehicle length restriction in Tannage Brae and Knowehead, Kirriemuir.

1. **RECOMMENDATION**

It is recommended that the Committee agree to the promotion and, if no objections are received or any objections are withdrawn, the making of a Traffic Regulation Order to provide an exemption, for refuse collection vehicles, to the current vehicle length restriction in Tannage Brae and Knowehead, Kirriemuir and on other roads leading from them.

2. ALIGNMENT TO THE ANGUS LOCAL OUTCOMES IMPROVEMENT PLAN/CORPORATE PLAN

3. BACKGROUND

3.1 Reference is made to Article 11 of the minute of meeting of the Communities Committee held on 24 May 2016 at which it was agreed to the promotion and making of a Traffic Regulation Order to provide an exemption to current weight limit restrictions in Tannage Brae and Knowehead, Kirriemuir for refuse vehicles.

4. PROPOSALS

- 4.1 At present, over the entire lengths of Tannage Brae and Knowehead, Kirriemuir there is a maximum vehicle length restriction of 17 feet (5.2 metres). The restriction on these roads is for environmental purposes, rather than any structural defect affecting these roads, insofar as the nature of the roads makes them unsuitable for regular use by long vehicles. There are numerous residential and commercial properties located along the affected road and the current Traffic Regulation Order (TRO) relating to these restrictions does provide exemptions for vehicles being used for the conveyance of goods or merchandise to and from properties adjacent thereto and in connection with any building or maintenance works to these roads or services located therein or buildings adjacent thereto. However it has been noted that there is no formal exemption to the vehicle length restriction in the current TRO to permit vehicles being used for collection of refuse in the service of a Local Authority.
- 4.2 The Waste Operations service has requested that this omission be rectified to permit their vehicles, which exceed the maximum vehicle length restriction, to legally utilise these roads for the collection of refuse from premises served directly from these roads and on other roads leading from Knowehead and Tannage Brae. A location plan of the affected roads is shown in **Appendix 1**.

5. FINANCIAL IMPLICATIONS

5.1 There are no financial implications arising from this proposal as no new or alteration to existing signage in the area will be necessary.
