# 4. PLANNING APPLICATION - FIELD 525M SOUTH EAST OF PITSKELLY FARM, PITSKELLY, CARNOUSTIE

There was submitted Report No 390/18 by the Service Leader – Planning and Communities detailing application No. 18/00778/PPPM by Blackwood Developments Ltd for residential development of around 260 dwellings incorporating formation of access roads, landscaping, associated infrastructure and a cemetery extension on land southeast of Pitskelly Farm, Pitskelly, Carnoustie. The application was recommended for refusal.

Mr Alan Hunter, Manager – Development Standards, gave a detailed presentation to members on the application, following which he answered members' questions.

Thereafter, Mr Cullen, agent for DJ Laing Homes and KD Henderson, developer and landowner respectively, objectors, and Mr Finc and Mr Szylak of Rick Finc Associates, on behalf of the applicant, addressed the meeting and answered members' questions.
