#### 4. PLANNING APPLICATION – LAND AT SHANK OF OMACHIE, WELLBANK

With reference to Article 4 of the minute of the Special meeting of Angus Council of 26 April 2016, there was submitted Report No 149/19 by the Service Leader – Planning & Communities detailing planning application No. 19/00095/PPPM by Forbes of Kingennie for an application under Section 42 of the Town and Country Planning (Scotland) Act 1997 for the formation of an 18 hole championship golf course, golf academy, hotel, spa and lodges, golf clubhouse, 160 residential plots and associated accesses on Land at Shank of Omachie, Wellbank without complying with Conditions 1, 4 and 6 subject to which planning permission 15/01045/PPPM was granted in order to enable the delivery of the hotel and spa or golf course in advance of any residential development and to reflect changes in developer contributions. The application was recommended for conditional approval.

Mr Alan Hunter, Manager - Development Standards, gave a detailed presentation to members on the application, following which he answered members' questions.

Thereafter, Professor Lennon, the applicant's agent and Mr Forbes the applicant, addressed the meeting and answered members' questions.
