PROHIBITION OF DRIVING AT ALLAN STREET AND APPLEGATE ARBROATH - SITE VISIT UPDATE

REPORT BY THE DIRECTOR OF INFRASTUCTURE

ABSTRACT

This report seeks to update the Council on the site visit held in Allan Street and Applegate Arbroath on 7 June 2019.

1. **RECOMMENDATION**

It is recommended that the Council agree to the promotion and, if no objections are received or if any objections received are withdrawn, the making of a Traffic Regulation Order to prohibit the driving of vehicles on sections of Allan Street and Applegate, Arbroath.

2. ALIGNMENT TO THE ANGUS LOCAL OUTCOMES IMPROVEMENT PLAN/CORPORATE PLAN

- 2.1 This report contributes to the following local outcomes contained within the Angus Local Outcomes Improvement Plan Locality Plans:
 - Safe, secure, vibrant and sustainable communities.

3. BACKGROUND.

3.1 The minute of Communities Committee on 28 May 2019 which considered Repot No 170/19 records that the Committee deferred the matter for a site visit as Arbroath members were unfamiliar with the location.

4. DETAILS

- 4.1 The site visit to Allan Street and Applegate took place on 7 June 2019. Members of the Communities Committee, local Arbroath members and Angus Council officers were in attendance.
- 4.2 Discussions took place over the current situation and the proposed 'Prohibition of Driving' restrictions following which the decision of the members attending the meeting was that they agreed to the proposed restrictions.

5. PROPOSALS

5.1 The Council is asked to agree to the promotion of the necessary Traffic Regulation Order to introduce 'Prohibition of Driving' restrictions on section of Allan Street and Applegate, Arrbroath.

6. FINANCIAL IMPLICATIONS

6.1 The estimated cost of implementing these proposals is £350 which will be met from the 2019/2020 Roads Revenue Budget. Additional maintenance costs will amount to £35 per annum and this will require to be provided for in future years Roads Maintenance Revenue Budgets.

7. CONSULTATION
