The report must also include an update on progress in securing any elements of the funding package that were indicated as anticipated in the application form and or are still required to be confirmed in order that the project can commence. Please note that that delays in securing the

funding package which results in significant postponement in the projects start date may result in the offer of grant being withdrawn. A clear explanation of any revised timings will be required.

If for any reason you are unable to meet this deadline or you will not be accepting the grant you must inform us in writing as soon as possible.

Please enclose with your acceptance of grant, a letter on headed paper, which provides details of the bank account the grant should be paid into, including account name, bank address with post code, sort code and account number.

The acceptance and bank details must be completed by and relate to the Grantee.
