**ANGUS COUNCIL (REDFORD, TEALING AND A926 KIRRIEMUIR ROAD, FORFAR)
(VARIATION OF SPEED LIMITS) ORDER 2019**

Angus Council in exercise of the powers conferred on them by Sections 84(1) and 124(1) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended (which Act of 1984 is hereinafter referred to as "the Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Paragraph 20(1) of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as the "Angus Council (Redford, Tealing and A926 Kirriemuir Road, Forfar)(Variation of Speed Limits) Order 2019" and shall come into operation on the Thirty first day of January Two thousand and twenty.
2. The Order specified in the Schedule to this Order is hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the said Schedule.

This is the Schedule referred to in the foregoing Angus Council (Redford, Tealing and A926 Kirriemuir Road, Forfar) (Variation of Speed Limits) Order 2019.

In the **ANGUS COUNCIL (SPEED LIMITS) ORDER 1999** the Schedule annexed thereto is amended as follows:

In **PART III 40MPH SPEED LIMIT**

1. At item **11B KIRRIEMUIR ROAD, FORFAR (A926)** delete and replace with the following:-

11B KIRRIEMUIR ROAD, FORFAR (A926)

- (a) From a point 46 metres or thereby northwards from the southernmost extremity of its junction with Brechin Road (B9128) northwards then westwards to a point 140 metres or thereby east of its junction with St Ninians Road, Padanaram, a distance of 2.50 kilometres or thereby.
- (b) From the roundabout on the east side of the A90 Dundee - Aberdeen Trunk Road westwards to its entry and exit junctions with the A90, a distance of 150 metres or thereby.
- (c) From the roundabout on the west side of the A90 Dundee - Aberdeen Trunk Road eastwards to its entry and exit junctions with the A90, a distance of 135 metres or thereby.

2. After item **21. PADANARAM** insert the following:-

21A. REDFORD

That length of Dundee - Friockheim Road (B961) from a point 75 metres or thereby north of its junction with the private road to Slade Farm northwards for a distance of 180 metres or thereby.

21B. TEALING

- (i) That length of Dundee - Tealing - Auchterhouse Road from a point 40 metres or thereby east of the centre line of Coralden Bridge westwards for a distance of 150 metres or thereby.
- (ii) That length of Dundee - Tealing - Auchterhouse Road from a point 405 metres or thereby west of its west junction with A90 Dundee - Aberdeen Trunk Road eastwards for a distance of 150 metres or thereby.
