ABSTRACT

The aim of this paper is to update the Audit Committee regarding external, often national, reports that are of interest to the Audit Committee.

1.0 RECOMMENDATION

It is recommended that the Integration Joint Board Audit Committee note the publication of the reports described in this paper.

2.0 BACKGROUND

- 2.1 On a regular basis reports are published by external bodies that are relevant and useful to Angus IJB. As part of the 2016/17 External Audit process, Audit Scotland particularly recommended that Angus IJB consider the relevant Audit Scotland reports on a regular basis. The principle associated with Audit Scotland reports should be extended to other relevant reports. This report to the Audit Committee highlights reports of relevance, but also notes specific issues or potential actions that could emanate from those reports.

The October 2019 Scottish Government report re Health Budgets it to give an example of discussion at Health and Sports Committee.

The Audit Scotland report "NHS Tayside 2018/19 Annual Audit Report" is further background re NHS Tayside. During 2018/29, Angus IJB took assurance from the content of NHS Tayside's Annual Governance Statement. From the end of 2019/20, it is intended to share other Tayside IJB's Annual Internal Audit reports for information and background while still clarifying assurance issues via a sharing of Annual Governance Statements.

There are no specific actions for the Audit Committee arising from the above reports. The IJB will review how it shares information about relevant national reports, including the examples above, with Audit Committee members and Board members more generally in future.
