**ANGUS CHILD PROTECTION COMMITTEE ANNUAL REPORT 2018 to 2019**

**ABSTRACT**

This report presents the Angus Child Protection Committee (ACPC) Annual Report for 2018 to 2019.

**3. BACKGROUND**

- 3.1 The previous ACPC Annual Report covered the period from 2017 to 2018.
- 3.2. The Annual Report of the ACPC for the period April 2018 to March 2019 presents the work the ACPC has undertaken in Angus, individually and in partnership, to deliver national, Tayside and local child protection outcomes to improve the lives of vulnerable children and their families.
- 3.3 The Annual Report has been approved by the ACPC and the Angus Chief Officers Group.

**4. CURRENT POSITION**

- 4.1 The Committee have continued to work together to improve child protection practice in Angus.
- 4.2 Of particular note this year is:-

- New Independent Chair – Alison Todd took up the post of Independent Chair early in 2019.
- Learning and Development – The training and learning and development needs of individuals in Angus will be considered on a wider protecting people basis, reducing duplication of effort and ensuring workers are equipped to consider the needs of families as a whole and their subsequent responsibilities.
- PREpare Pilot – A pilot project to consider the participation of children and families within Child Protection Case Conferences, with a robust evaluation plan in place.
- Review of Processes – Both Angus Early Screening Group and Prebirth Resource Allocation Meeting (PRAM) have undergone review, with updated, streamlined processes in place
- Minimum dataset – a national minimum dataset for Child Protection Committees is proposed. Work has been undertaken with Tayside colleagues to ensure additional reporting measures to provide clear information, evaluate progress and identify future priority areas.
