REVIEW OF ANGUS COUNCIL CHARGES FOR SUPPORT AND CARE SERVICES AND RESIDENTIAL FEES 2020/21

REPORT BY VICKY IRONS, CHIEF OFFICER, ANGUS IJB

ABSTRACT

This report sets out proposals to revise Support and Care and Residential fees for services provided by Angus Health and Social Care Partnership through Angus Council with effect from April 2020.

1. **RECOMMENDATIONS**

It is recommended that Angus Council:-

- 1. Approves the proposed changes in charges for Support and Care Services as set out at 4.1 and 4.2 with effect from April 2020;
- 2. Notes the continued adoption during 2020/21 of COSLA guidance regarding 'income disregards' for the purposes of assessing client contributions;
- 3. Approves the proposed residential charges for Angus Council owned Care Homes as set out at 4.5 with effect from April 2020.

2. ALIGNMENT TO THE ANGUS LOCAL OUTCOMES IMPROVEMENT PLAN/COUNCIL PLAN

2.1 The proposals in this report contribute as a whole to the achievement of the Council's corporate priorities and the specific targets and objectives within the Council Plan and Local Outcomes Improvement Plan. The proposals also contribute to the achievement of the national health and wellbeing outcomes by ensuring resources are used effectively and efficiently in the provision of health and social care services.

3. BACKGROUND

3.1 While the responsibility for the operational delivery of Adult Services is devolved to Angus Health and Social Care Partnership (effective April 2016), the formal authority to charge for social work services remains with Angus Council. On that basis, Angus Council needs to formally approve planned amendments to charges as proposed by Angus Health and Social Care Partnership (Angus HSCP). Angus HSCP have considered charging arrangements for 2020/21 at the IJB meeting of January 2020 (see report xx/19) and their recommendations are set out in this paper. These recommendations are made in the context of the overall financial position of the Partnership. Previous recommendations were set out in report 53/18.

In early 2020, Angus HSCP is scheduled to agree a budget settlement with Angus Council to support the delivery of Adult Services. Due to the challenging circumstances facing both Angus Council and Angus HSCP, the settlement requires the Partnership to develop a series of proposals regarding charging related issues that reflect the challenging circumstances. Angus Council have previously advised they wish to use a common inflation index for all charges. Angus HSCP did not follow this position in 2019/20 for a variety of documented reasons. However for 2020/21, Angus HSCP does generally intend to adopt this uplift unless set out otherwise in this report.

The overall intention is to set out amendments to charges to increase income to support the ongoing delivery of the current volume of social work adult services, taking into account increased demands and costs, without undue detriment to service users and without destabilising front line services and service uptake.

In terms of managing the implementation of all recommendations, an implementation plan will be managed by Angus HSCP in conjunction with relevant support services.

4. PROPOSALS

4.1 CHARGES FOR ANGUS COUNCIL SUPPORT AND CARE SERVICES (ASSESSED)

Angus HSCP provides a range of support and care services which are chargeable. These services are charged for in accordance with the contribution policies and charges are based on each individual's financial assessment. These charges were last revised in report 53/19. The proposed general percentage uplift for 2020/21 is in line with Angus Council's recommended standard uplift.

2020/21 - 3.00%

This 3% uplift will also apply to charges made by Angus Council for day care services provided through independent sector.

Should the proposed 2020/21 uplift of 3% prove to be an understatement, then this may be remedied in future year's uplifts.

Contributions for College Support required to be revised following the implementation of a partnership model with Dundee and Angus College for the Supported Education Programme. This was described and approved at the Integration Joint Board (Report 41/19) and at Policy and Resources Committee (Report 281/19). There will be no charge for the support to those attending this programme and personal budgets will not be generated for this aspect of an individual's outcomes. For those attending other forms of further education, the contribution policy and fair cost of care will apply.

From 2020/22, charges for Glenloch are adjusted to reflect that the service is closed for 4 weeks per annum and the annual cost now reflects a 48 week per year service.

Reflecting changes to planned service delivery, new charges for Supported Accommodation at Provost Johnston Road, Montrose and St. Drostan's, Brechin will be developed during 2020. In future years a similar charge would also apply to service provision at The Gables once the new building there is opened.

The effect on individual services is shown in Appendix 1. The net financial benefit is estimated at c£33kper annum and is constrained by current contributions policies. It is important to recognise the cumulative effect over a number of years of any failure to inflation link costs.

4.2 CHARGES FOR ANGUS COUNCIL SUPPORT AND CARE SERVICES (FLAT RATE)

In addition to the services described at 4.1 charged against an individual's financial assessment, a small number of services are charged at a flat rate (outwith the financial assessment). These fees include Community Meals, Community Alarm and Telecare charges.

For 2020/21, it is now proposed to adjust these flat rate fees, in line with services described above but with some exceptions, by 3.0% for 2020/21 as follows:-

- 1. No uplift applied to retain standard charge at £1.
- 2. The above rates are rounded to nearest 5p.

The above recommendations take into account the current financial support of the Community Meals service, rates of inflation associated with service delivery (including annual increase of staff pay rates and consumer price indices) and guidance regarding chargeable costs. It is recommended to retain

the Telecare charges at £1/week as this is still a relatively new charge and the evening meal charge is held at £2.90 to reflect the differential with evening meals.

It has been assessed that the additional income that will be derived from the above increases is c£32k per annum. These changes in charges will help offset the increased costs associated with service delivery.

4.3 INCREASES IN THE TAPER APPLIED TO EXCESS INCOME

In 2019/20 the taper that applies to excess income was 75%. It is not proposed to revise this for 2020/21.

4.4 INCOME DISREGARDS

On an annual basis, COSLA make recommendations regarding income disregard levels. Previously Angus Council has implemented these recommendations for under 60s and over 60s. It is recommended that Angus Council continues to adopt the income disregards guidance as set out by COSLA for 2020/21.

4.5 RESIDENTIAL FEES

On an annual basis, rates need to be agreed for the weekly cost of in house residential services. Section 22 of the National Assistance Regulations requires local authorities to set the standard rate for local authority homes at an amount equivalent to the full cost to the authority of providing the accommodation. For 2019/20 rates were set at £620/week for mainstream Older People's residential care at Kinloch, Beech Hill and Seaton Grove and £1059 per week for High Dependency Units. It is known that the cost of delivering mainstream care in all 3 Older People's Care Homes is above the 2019/20 mainstream Charging rate.

It is now proposed that the 2020/21 residential fee now more closely matches the full cost of service provision. It is also proposed that, mirroring the evolving nature of service delivery, there will no longer be a discrete charging rate for High Dependency Units, with all services being charged for at the mainstream rate. Noting that costs do vary widely across Seaton Grove, Kinloch and Beech Hill, it is proposed that for 2020/2021 fees are set at a rate equivalent to the costs of service provision at Seaton Grove (£931). This could be reviewed in future.

Costs for The Gables (Learning Disability residential care), were also previously calculated in the same way as Older Peoples residential charges. More closely matching The Gables charges with the full cost of service provision suggests a weekly rate of £1093 per week.

It is important to note that, while this is a significant change in charges – with a small part of it attributable to annual inflation, services users only pay this cost or a contribution to this cost, if they have had a financial assessment that indicates they can afford to contribute to this cost. These changes in charges will help offset the full costs associated with service delivery.

It has been assessed that the additional income that will be derived from the inflation component of the above increases in mainstream residential is c£179k per annum, assuming no reduction in services users who contribute to the cost of their care.

The financial impact on the HSCP of the move to link mainstream residential charges more directly with the costs of service provision and then the removal of the High Dependency Unit rate is more difficult to determine due to the variable numbers of service users in these Care Homes who make full financial contributions to the cost of care. For budgetary purposes, it is assumed to contribute to an increase in income of c£50k per annum.

Step down/Intermediate Care provision will continue to be free to service users for up to 4 weeks as the service is commissioned in entirety.

All charges are consistent with the CRAG (Charging for Residential Accommodation Guidance) regulations laid out by COSLA and are compatible with our statutory duty to assess need and to promote the client's best interests.

4.6 CHARGING FOR RESPITE SERVICES

Report 53/18 noted that Angus HSCP was reviewing the charging for respite services. This review remains ongoing and should be clarified during 2020.

4.7 FREE PERSONAL CARE

From April 2019 the Scottish Government introduced changes regarding Free Personal Care for under 65s. This change was funded through discrete Scottish Government funding and the lost income (as care became "free") was covered by additional Scottish Government funding. The Scottish Government also recognised there was a likelihood of increased long term growth in the uptake of personal care amongst the under 65s (once it became free). This long term growth may put pressure on budgets in futures years.

4.8 CHARGES AND CONTRIBUTION POLICY

As noted in report 53/19, Angus IJB operates contributions policies for Support and Care Services. These policies have developed over a number of years and work is ongoing to consolidate the current policies and guidance with the intention of this being reported back to the Board.

5. FINANCIAL IMPLICATIONS

5.1 The relevant financial impact of the changes are described in the sections above. As noted at 3.1, assumptions regarding income are reflected in the overall proposed budget settlement between Angus Council and Angus HSCP. The overall assumption, reflected in Angus IJB's financial plans, is that from 2020/21 additional charges of £294k should be allowed for.

On an annual basis Angus HSCP generates c£10m of income. This reflects charges for both Support and Care and Residential Services. Income streams are routinely monitored through corporate support arrangements. In any given year there can be an element of bad debt. Unpaid invoices are continually reviewed and recovery is in line with Council procedures. Write offs are only considered after all means of recovery have been explored. There is currently an increased level of concern regarding debt issues within the HSCP partly as a result of staff turnover, with its consequent loss of continuity, and also in terms of determining the HSCP financial exposure to issues related to debt management.

6. RISKS

6.1 There are risks that the increase or introduction of charges could have a detrimental effect on service uptake. This type of risk is already managed within operational services and the impact of any change would be closely monitored.

7. EQUALITY IMPLICATIONS

7.1 There are equality implications arising from this report and an Equality Impact Assessment has been completed and is attached at Appendix 2.

What data/research is available to assess the likely impact of the proposed saving?

The number of people affected by the change in charging is known. We have benchmarked proposals against charging in other local authority areas of Scotland. The proposed general percentage uplift for 2020/21 is in line with Angus Council's recommended standard uplift.

A 3% increase is to be applied to Community Meals and Community Alarm. Charges for these services are applied to all people who use these services. 3471 number of people use community alarm. Users of community alarm tend to be over the age of 75 years. People who use community alarm represent 29% of the over 75 population in Angus. 469 people use community meals services this represents around 4% of the population aged over 75.

On an annual basis, rates need to be agreed for the weekly cost of in house residential services. Section 22 of the National Assistance Act requires local authorities to set the standard rate for local authority homes at an amount equivalent to the full cost to the authority of providing the accommodation. For 2019/20 rates were set at £620/week for mainstream Older People's residential care at Kinloch, Beech Hill and Seaton Grove and £1059 per week for High Dependency Units. It is known that the cost of delivering mainstream care in all 3 Older people's Care Homes is above the 2019/20 mainstream Charging rate.
