### MAY DAY PUBLIC HOLIDAY

## ABSTRACT

This report seeks approval to move the May Day public holiday in 2020 for Local Government Employees and for schools from Monday 4 May to Friday 8 May (VE Day) (subject to approval also by the Children and Learning Committee on 18 February 2020.)

### 1. **RECOMMENDATION(S)**

It is recommended that the Policy & Resources Committee:

(i) agrees the May Day public holiday in 2020 be changed from Monday 4 May to Friday 8 May (VE Day);

It is recommended that the Children and Learning Committee:

(i) approves the change to the May Day school holiday for 2020 to align this with the council date.

## 3. BACKGROUND

May Day is traditionally held on the first Monday in May but the Scottish Government changed this for 2020 to coincide with the 75<sup>th</sup> anniversary of VE Day. The last time this change was made was in 1995 to commemorate the 50<sup>th</sup> anniversary of VE Day.

### 4. CURRENT POSITION

The May Day public holiday is normally taken on the first Monday in May. In 2020 this would fall on Monday 4 May.

The school holiday dates for 2019/2020 were approved in 2017 when the May Day holiday was agreed as Monday 4 May. At that time there would have been no indication that this date would change. In June 2019 Head Teachers were advised that the May Day holiday would be changed to Friday 8 May 2020 and asked to notify parents/carers to give adequate time for childcare planning. The revised dates were published on the council website at this time. Due to an oversight, committee approval was not requested for this change. However, as the changes have already been communicated it is noted that there will be no adverse impact to parents/carers as a result of the proposals in this report.

## 5. **PROPOSALS**

It is proposed that the May Day public holiday in 2020 be taken on Friday 8 May instead of Monday 4 May.

## 6. FINANCIAL IMPLICATIONS

There are no financial implications associated with this proposal.
