ANGUS COUNCIL (DISABLED PERSONS' PARKING PLACES) (OFF STREET PARKING PLACES) (DECRIMINALISED ENFORCEMENT)(VARIATION) ORDER 2020

Angus Council in exercise of the powers conferred on them by Sections 1(1), 2(1) to (3), 4, 32, 35(1) and (3), 3(A), 35A, 35B, 35C, 46 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended ("the Act of 1984"), the Road Traffic Act 1991, the Disabled Persons' Parking Places (Scotland) Act 2009 and of all other enabling powers in these Acts and otherwise, after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order:-

1. This Order may be cited as the "Angus Council (Disabled Persons' Parking Places)(Off Street Parking Places)(Decriminalised Enforcement)(Variation) Order 2020" and shall come into operation on the Twenty eighth day of February Two thousand and twenty.
2. The Order specified in the Schedule to this Order is hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the said Schedule.
