**ANGUS COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND
LOADING)(ON-STREET PARKING)(DECriminalISED ENFORCEMENT)(VARIATION)
ORDER 2020**

Angus Council in exercise of the powers conferred on them by Sections 1(1), 2(1) to (3), 4, 32, 35, 45, 46 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended, the Road Traffic Act 1991 and of all other enabling powers in these Acts and otherwise, and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order:-

1. This Order may be cited as the "Angus Council (Prohibition and Restriction of Waiting and Loading)(On-Street Parking)(Decriminalised Enforcement)(Variation) Order 2020" and shall come into operation on the Twenty eighth day of March Two thousand and twenty.
2. The Order specified in the Schedule to this Order is hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the said Schedule.

This is the Schedule referred to in the foregoing Angus Council (Prohibition and Restriction of Waiting and Loading) (On-Street Parking) (Decriminalised Enforcement) (Variation) Order 2020.

The **ANGUS COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING) (ON-STREET PARKING) (DECRIMINALISED ENFORCEMENT) ORDER 2017** is amended as follows:

- A. In the Order Exemptions for vehicles displaying a valid disabled person's badge 79. is amended as follows:-

The words “, other than a parking place identified in the Plans and listed in Schedule 3 as permit holders only parking places,” shall be inserted at the end of line 3 after the word “place” and before the word “if”

- B. In Schedule 2 Plans with the following Map Numbers are deleted:-

AH – E06 AH – E07 AH – G06
BN – D04 BN – E03
ME – B04 ME – B05 ME – B06 ME – B07 ME – B08 ME – C04

- C. Plans attached to this variation order with the following Map Numbers thereon are added and incorporated into Schedule 2:-
