As a consequence, there will be a greater requirement for Councillors to be aware of when, outwith the Code, there are relevant legal obligations in terms of duties owed to outside bodies.

The lobbying provisions are clearer in terms of when this is appropriate and when it is likely not to be appropriate. It is helpful that the Code now provides that there may be circumstances in which it is best not to respond to a constituent, and that councillors are not obliged by the Code to respond to every contact. It is noted that the data protection obligations in terms of sharing personal data with other councillors in a multi-member ward seem to go further than that provided in the ICO guidance on this matter.
