THE ANGUS COUNCIL (U394 WEST BALLOCH KIRRIEMUIR) (TEMPORARY PROHIBITION OF  
DRIVING) ORDER 2021

Angus Council in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 and of all other powers enabling them in that behalf being satisfied that traffic on the road or roads referred to in this Order should be restricted or prohibited because works are being or are proposed of drainage works to be executed on or near the said road or roads, hereby make the following Order: -

1. This Order may be cited as "The Angus Council (U394 West Balloch Kirriemuir) (Temporary Prohibition Of Driving) Order 2021" and shall come into force from 25 January 2021 from which date it is anticipated that the works will last for a period of 14 days, however, the maximum duration in terms of said Act is 18 months, for the purpose of drainage works.
  
2. Save as provided in Article 3 hereof, no person shall cause or permit any vehicle to drive or be driven on U394 Aucharroch Road at a point 335m west of its junction with the C25 for a distance of 100m or thereby.

The alternative route is U394 Aucharroch Road, C27 Kirriemuir - Glen Prosen road, U395 Kinnordy Road, B951 Kirriemuir - Glenisla – Glenshee road, U934(1) Aucharroch Road.

Access for pedestrians, residents and emergency vehicles will be maintained.

3. Nothing in Article 2 of this Order shall apply so as to prevent any person from causing any vehicle to drive or be driven in the length of road specified in that Article if the vehicle is being used: -
  - (a) in connection with any building operation or demolition in or adjacent to that length of road, the removal of any obstruction to traffic in that length of road, the maintenance, improvement or reconstruction of that length of road, or the laying, erection, alteration or repair in or adjacent to that length of road of any sewer or drain or of any main, pipe or apparatus for the supply of gas, water or electricity or of any electronic communications apparatus as defined in sub-paragraph 1(1) of Schedule 2 to the Telecommunications Act 1984;
  
  - (b) for Police, Fire Brigade or Ambulance purposes or in the service of a local authority in pursuance of statutory powers and duties;
