ABSTRACT

This report presents the Angus Community Justice Partnership Annual Activity Return for 1 April 2019 to 31 March 2020.

3. BACKGROUND

- 3.1 The previous Angus Community Annual Activity Return report covered the period from 1 April 2018 to 31 March 2019.
- 3.2 The Annual activity return report presents the work undertaken by individual services within the Angus Community Justice Partnership and collectively as a partnership to deliver National, Tayside and Local Justice outcomes to improve the lives of individuals within the Justice system or on the periphery during the period 1 April 2019 to 31 March 2020.
- 3.3 Angus Community Justice Partnership also have a statutory obligation to provide the Community Planning Partnership (CPP) with an overview of the work undertaken by the partnership over the reporting period.
- 3.4 The Angus Community Justice Partnership Annual Activity Return Report 2019-20 has been approved by the CPP.

4. CURRENT POSITION

- 4.1 The ACJP have continued to work together to promote the safety and wellbeing of the citizens of Angus and deliver services to support their specific needs.
- 4.2 Of note during this period:
 - Awareness Sessions ACJP were involved in arranging various awareness sessions for staff within Angus Council and the Third Sector to provide information sharing/networking opportunities on the work they undertake and promote a collaborate working relationship.
 - ACJP are in the process of reviewing the ACJP Outcome Improvement Plant with the aim
 of developing a one-year plan for 2021-22 to reduce duplication of work, make best use
 of resources and support the citizens of Angus.
 - Eradicating Gender-based violence (GBV) is a primary goal of the partnership. To support
 this goal, surveys have been sent out to victims, services involved with victims and those
 who perpetrate GBV, along with two focus groups for frontline professionals involved with
 victims. Next steps; survey for those who perpetrate GBV to gather their view. Information
 from these will identify any gaps in services to be addressed.
